**Item No.4. Resolution 10-039.** The Providence City Council will consider for adoption a resolution increasing the license fees for dogs.

**Item No.5. Ordinance No 012-2010.** The Providence City Council will consider for adoption an ordinance amending Providence City Code Title 11 Subdivision Regulations, Chapter 3 Plat Procedures and Requirements, by adding a maximum size for plats being submitted for review.

Ordinance No. 013-2010.** The Providence City Council will consider for adoption an ordinance amending Providence City Code Title 3 Business and License Regulations, Chapter 8 Solicitation License, by allowing an interim license with a BCI background check prior to receiving the nationwide background check.

**Item No. 7. Discussion.** The Providence City Council will discuss sewer rates and the impact of the increased rate and capital project fees being billed by Logan City.

informational only; no formal action will be taken. The City Council may act on an item, if it arose subsequent to the posting of this agenda and the City Council determines that an emergency exists.


**Executive Session:**
