11 **ACTION ITEM:**

12 **Item No. 1.** The Providence City Land Use Authority intends to deny a request to renew the family child care license of
13 Kim Baer located at 250 North 100 East.

14 K Baer was notified by letter on February 4, 2011 of this meeting. She was also sent a copy of the agenda. The City has
15 not heard from her and she is not in attendance.

16 Terri Wennergren sent K Baer a letter letting her know that because the State of Utah is revoking her license, the City
17 will start the denial process. She was told she has the right to present evidence as to why the license should not be
18 denied.

19 S Bankhead read the letter.

20 S Bankhead said in 2008 K Baer obtained an active child care license from the State. It was in effect until January 2011.
21 The State sent a letter stating that Kim Baer's child care license is being revoked.

22 R Eck asked if it is the responsibility of the City to make sure she has disenrolled the children.

23 S Bankhead said that is the State's responsibility.

24 S Bankhead said K Baer has the right to appeal per City Code Title 2, Chapter 5, Section 3. A letter will be sent as to the
25 decision of this meeting.

26 K Baer was still listed as active in November 2010. She paid her business license fee in January 2011. At that time
27 T Wennergren checked again with the State and found that K Baer's license was no longer active.

28 M Pierce said she has until February 28th appeal the State's decision. Are we jumping the gun?

29 S Bankhead said if you chose to deny her business license you will list the reason as no child care license by the State. If
30 she obtains a license later we could re-instate the license

31 **R Eck made the following motion: because we are a subdivision of the State and she has no State license we have**
32 **no choice but to deny her license. If we obtain information later that the State has reinstated her license then the**
33 **City will look into also reinstating her license.**


