Approval of the minutes

Item No. 1. The Providence City Council will consider approval of the minutes from the August 23, 2011 City Council meeting.

Public Hearing: The Providence City Council will hold a public hearing at 6:20 p.m. to receive public comment on adjusting the budget for fiscal year 2012 for the following funds: General, Capital Project, Water, Sewer, and Storm Water.

Business Items:

Item No. 1. Resolution No. 11-022. The Providence City Council will consider for adoption a resolution adjusting the 2012 Budget for the following funds: General, Capital Project, Water, Sewer, Storm Water.

Item No. 2. Resolution No. 11-023. The Providence City Council will consider for adoption a resolution requesting the recertification of the Providence City Justice Court.

Item No. 3. Resolution No. 11-024. The Providence City Council will consider for adoption a resolution increasing the water rates as follows: Base Rate \$23.25 (includes 10,000 gallons of water), Excess Water Rates; 10,001- 50,000 gallons \$0.75 per 1,000 gallons, 50,001 and more \$1.50 per 1,000 gallons.

Item No. 4. Discussion. The Providence City Council will discuss the ticket price for the sauerkraut dinner.
