APPROVAL OF THE MINUTES:

The Providence City Planning Commission will consider for approval the minutes of October 12, 2011.

ACTION ITEM:

Item No. 1: The Providence City Planning Commission will consider for recommendation to the City Council a request from Ivan Christensen to rezone the property located at 207 East 100 North from the current SFT Single-Family Traditional (required 12,000 square foot lots) to SFR Single-Family Residential (10,000 square foot lots). The Providence City Planning Commission will also consider for recommendation to the City Council a request to amend the ordinance change to allow 10 foot rear setbacks for Single Family Residential in the Downtown Area.

STUDY ITEMS:

Item No. 1: The Providence City Planning Commission will discuss amending the ordinances with regard to lot consolidation and building non-dwelling unit structures. Examples of such non-dwelling structures, but not limited to those listed, are as follows.

1. Swimming Pools
2. Tennis Courts
3. Club Houses
4. Private Play Grounds
5. Light Manufacturing Facilities
6. Barns
7. Storage Structures, etc.


Item No. 2: The Providence City Planning Commission will discuss amending Providence City Code Title 10, Chapter 15, Sign Regulations.
