 - a. Repaired snowplow for the Township for various issues
 - b. Took gravel from Stark to put on Cleveland to repair low spot related to Sewer work

 - d. Met with Misch to discuss Cleveland Street Extension. He was in agreement of approach and offered to assist with work.
- 6) Financial Report for MFT and SAS Funds
 - a. Reviewed current snow removal budget to reconcile spend. January blizzard has yet to be added to spend which will take us over budget.
 - b. Reviewed Labor (Les) Budget We are expected to stay within budget through end of year.
 - c. Reviewed Motor Fuel Budget Staying well within Budget but we expect some additional outlays associated with weather change and aged streets. Total income to date is \$14,795 which is only 73% of what we are to receive.
 - d. SAS Budget Reviewed numbers and are running within budget. Have brought in slightly more income than projected. There will be some additional expendatures related to purchasing culverts, cold patch and gravel. We may be getting some salvaged culverts from Fisher.

7) Discussion Items

- a. Sewer Road Repair Repaired streets have issues related to sinking will and need to be addressed.
- b. Snow plowing Reviewed with budget. Discussed 2/24 (5-7 inches expected with mixture over weekend) pending snowfall strategy. Used most recent snowfall to identify areas for improvement going forward. Some issues were brought forward related to hard frozen snow and first pass town cleanup. With last snowfall, village snowplow had breakdown which impacted village removal. As a result, Joe's removal effort was made more difficult. We will use this as a learning experience to improve operating plans going forward.
- c. Sidewalks Need to begin developing strategy for 2011-2012.
- d. Street signs Ordered sample, due in anytime.
- e. Lincoln Street extension discussed options. See 5d above.
