Casali and Sons

Homeowners would need to provide the cans for recycling items would not have to be separated as long as it does not exceed the weight limit. The current garbage contract is up in April, Casali would like the board to consider doing an extension of the current contract.

Public Comment

Status of the Lincoln Road and what are snow removal plans

Lincoln Street will not be addressed until next year- we don't have the resources to do anything at this point

Snow removal will be done by the Village not contracted out.

Motion to approve Resolution approving an amended intergovernmental agreement with BNWRD by Mike Sumner

Discussion

Don't have much wiggle room, the Village is at the mercy of BNWRD. Village approves the agreement then it goes to BNWRD, the Village has to follow the BNWRD rules. Moving forward if you have constituents outside the corporate limits of Downs that want to have access to the sewer the Village cannot allow just sewer service. If a subdivision wants to be annexed in, the Village would have to responsible for everything including roads. Property can be annexed in but it the Village will have to get BNWRD approval before it can be done. BNWRD has to give approval to let them be included in the Village sewer system.

BNWRD is more worried about large industrial buildings

We have already discussed that we cannot maintain the tax amounts.

Who is going to figure all the amounts to be put on the bills? BNWRD will help set up the data base.

BNWRD may have some software for us to use – it's every parcel regardless if they are hooking up or not.

The Village pushed hard on the issues that could be negotiated. The intent was not to let BNWRD take total control. Any changes to the ordinance need to be approved by BNWRD

Discussion

Need to have a back up which could be contracted with another municipality

Part of the fee is set aside for that portion of the expense. This will be a Village employee that has the Village best interest in mind and expertise to give for the water plant, sewer plant and roads maintenance.

The Village equipment will be used and can use intergovernmental with other municipalities. The ordinance is broad but the employee does not have to do everything that is listed in the ordinance.

It does provide for supervisor of the meter reading personal – don't want that. The meter reader and the water personnel need to be supervised by the billing department

The Village has less risk by having an employee than a contractor.

This position would only be paid by water and sewer no other money

Back up services will be intergovernmental agreements

Discussion

An agreement cannot be located- the completion of the road needs to be done according to the Ordinance

There is a responsibility as a village to make sure the road is complete

If no agreement can be found the developer has to adhere to the Ordinance.

Wanted to establish a timeline back in 2010 and Misch was asked to tag onto the timing of the sewer work being done on that side of town.

Nothing will be done until spring at this point

Owe it to the homeowners to set a deadline based on the ordinance.

From a legal stand point you need to do a resolution spelling out exactly what needs to be done and when
