Mayoral Update

November 4, 2012

Dear Citizens,

Very soon the Village will have new "Welcome to Downs" signs along Seminary Street welcoming everyone as they enter the village. Local Eagle Scout candidate, Ben Stinemates has been working for months on this project and should have them completed before Thanksgiving. Excellent work, Ben! The Village Hall rehab is progressing well and we should be moved in by January 2013. Thanks to the dedication and leadership of Trustee Paul Myszka and the volunteers who have put significant hours to make this project possible. There is much work being done to help improve our downtown area and we will all benefit from these improvements.

Another improvement that the village has been working on is our water system. Hopefully, everyone has noticed an increase in the clarity of water and a decrease of the rusty discoloration during the month of October. Kevin Whitehouse, our Public Works Superintendent, has been working six days a week since February to improve the water quality and plant operations, and last month decreased the iron content levels from 1.5ppm to .3ppm. That is a huge decrease in the content of iron in our water! Changing this position from a part-time position to a full-time position is already improving the quality of our water treatment system. Thank you to Kevin for the hard work and the countless hours he has put in to make the necessary improvements to our water system.

In previous updates, I introduced the McLean County Highway Department re-work of Washington Street. As this work is being done, the Village will be replacing the transit pipe with a new water line east of the school administration building to service the homes in that area. We should have a status update of this project in the next few months with work beginning in June 2013.

Please remember to read through this flyer for important information regarding upcoming community events and Chief Deerwester's retirement reception. I hope everyone can stop by and thank him for his years of dedication to the safety of all of us.

VILLAGE OF DOWNS FINANCIAL REPORT, NOVEMBER 2012

October marks the end of the sixth month into the fiscal year and the opportunity to provide a mid-year update from the Finance Department.

The slow recovery from the recession continually challenges us to monitor expenditures and find ways to reduce costs and provide services as efficiently as possible. My recommendation to create a strategic budget and planning process will help us to carefully scrutinize Village budget requests and spending patterns. This process will help us to plan, develop and establish short-term and long-term financial goals for each department.

The past six months have been historic for the Village with the completion of the sewer project. Currently we have 258 constructions completed from the 274 permits issued. Close oversight will be given to the IEPA loan repayment. Sewer loan balance is \$5,668,091.

Down's Crossing will provide new opportunities for future economic growth and development. In pursuing a new TIF district, the emphasis should be on new development. The newly reconfigured Cross Creek development will bring a new housing market and property tax monies to the TIF district.

The soon-to-be completed renovation of the Village Hall will enhance both work and meeting space, making the building ADA compliant and more accessible for citizens. A handicap parking space will be created in front of the Village Hall.

Risk Management

The Village's shift to acquiring commercial insurance with IMLRMA in 2010 continues to be a savings with premiums for liability insurance costing \$10,833.

Budgets

Over the next six months, the finance committee will closely monitor line items and work closely with departments to not exceed budgets. Currently, individual funds are within budget. Thank you to Ruth Hood and Janice Cuba for their hard work and determination to work through billing challenges associated with the sewer permit and connection process. Thank you to Village Treasurer Janice Cuba for her expertise in handling the financial complexities related to the disbursements of the sewer construction project and ongoing budgeting processes.



Village Code Chapter 12 Section 2 TURNING ON: No water from the Village water supply shall be turned on for service to any premise by any person but the Village Water Superintendent ("Superintendent") or some person authorized by the Superintendent to perform this service. An unauthorized water turn on shall result in a \$400 Four Hundred Dollar fine to Applicant.

Village Code Chapter 12 Section 4 Deposit: A Deposit shall be made with each Application. The Deposit shall be retained by the Village as security to insure an Applicant's payment of all bills for water service. The amount of this Deposit shall be determined by the Village Board from time to time. When service to the Applicant is discontinued, the Deposit, less any past due or current balance owed to the Village for water service shall be refunded to Applicant without interest. The current Deposit is \$100.

In the event that the undersigned Applicant fails to make the required payment(s) for water service on the required date(s), an Event of Default will be deemed to have occurred on the earliest date that Applicant fails to make said payment(s). Village will allow Applicant seven (7) days from the Event of Default to cure the Default by Applicant doing one of the following: (i) tendering full payment to Village of the past due balance; or (ii) entering into an acceptable Installment Payment Agreement with Village. If Applicant fails to cure said Event of Default as provided for herein then, in addition to the assessment of late fees and disconnection of the water service, Applicant hereby consents and agrees that the Village shall be allowed to obtain a Confession of Judgment against Applicant in the Circuit Court of McLean County without further notice to Applicant.

By applying for water service, Applicant consents and agrees that: 1) Village can obtain said Confession of Judgment without extending further due process to Applicant; and 2) Village can obtain said Confession of Judgment for the total amount due for water service under the ordinances of the Village, less any payments previously made by Applicant, together with a Confession of Judgment for late fees, reasonable attorney's fees and costs incurred by Village in procuring said Confession of Judgment against Applicant.

NOTE: "Confession of Judgment" as used herein, means that in the Event of Default and failure to cure by the Applicant, as provided herein, the Village can confess a judgment against Applicant without further hearing or opportunity to dispute or object to the judgment.

Upon making application for water to be turned on at the above address, I do accept and agree to abide by all of the provisions of the Village of Downs Water Department as stated in the Code of the Village, as conditions governing the use of the Village water supply and further acknowledge, agree and accept the conditions set forth within this Application, including the Confession of Judgment provisions set forth herein.


