From the Desk of the Mayor - December 2015

Merry Christmas and Happy New Year!

Another busy month as we wind down to the end of the calendar year and work to wrap up our new TIF District.

This month we held the required Zoning Board of Appeals (ZBA) and public hearing for five annexations within the new TIF district. All five annexations and rezoning were approved unanimously by the ZBA and Village Board. This sets the stage for the final act needed before adoption of the new TIF, which is subdividing of existing farm ground contained within the TIF. These plats will be considered once completed and will push the adoption of the TIF out a few months because of posting and notification requirements.

We also passed out annual tax levy as presented and covered last month:

Other business taken up: biweekly payroll, additional improvements on the new village building, and a revised redevelopment plan for TIF 1.

Finally, we are extremely proud of our Tri-Valley Viking football team that fulfilled their goal of "finishing" the business from 2 years ago. Congratulations to the Team, coaching staff and school on this fantastic accomplishment. The Village Board unanimously declared November 27, 2015 as "Tri-Valley Viking IHSA Class 2A Football Championship Day".



Finance Trustee Position Open

PLEASE CONSIDER SERVICE TO YOUR VILLAGE

The Mayor will be accepting letters for consideration for only this position. Your term of office will be the remaining months until April 30, 2017. If you decide to continue, you will need to run for a four-year term in the 2017 April election. You will be paid \$125 per regular or special board meeting.

You are eligible to be a Trustee if you are a registered voter and a resident of Downs for at least one year prior to the date of the election. A person is not eligible to take the oath of office for a municipal office if that person is, at the time required for taking the oath of office, in arrears in the payment of a tax or other indebtedness due to the municipality or has been convicted in any court located in the United States of any infamous crime, bribery, perjury, or other felony [65 ILCS 5/3.1-10-5(a)(b)]s.

BUILDING PERMIT REMINDER

Please remember to apply for a building permit **before** any construction, alteration, moving, structural repair or demolition, interior or exterior, of any structure, or any excavation within the corporate limits of the Village. If the estimated cost or proposed work and material exceeds \$2,000.00, then the application will need to be accompanied by plans or drawings and specifications sufficient to show that the minimum requirements of the building ordinance will be met.

Also, be aware that there is a Small Project Application available, which includes decks of 150 square feet or less, permanent or moveable sheds, fencing, and roofs.

Water and sewer report for November 2015

12/3/2015

The sewer lift station delivered 1,599,000 gallons to BNWRD for the month, averaging 53,300 per day. The total water pumped for the month was 2,018,400 gallons for an average of 67,300 gallons per day. The average iron concentration in the finished water remained the same at .39 PPM. The known service line leaks on Woodlawn and on Fox Run have been repaired along with another service leak on North Gadwall. The plant flows have stabilized around 62,000 a day. A possible storm water inflow to the sewer system was located by Mayor James, additional testing and possible repairs will follow. The (filter backwash water) red water filter is in need of media replacement, it is plugged and will no longer allow water to pass through. We are currently allowing to the solids to settle out then pumping the water out to the normal discharge location. The media replacement is being considered for in house work or bids will be sought.

Parks' Committee Report

At our November meeting, the Parks' Committee continued to refine the Dooley Park Rental Agreement and Checklist. When renting the Pavilion, you'll need to pay the rental fee and cleaning/damage deposit **separately** in order to get your refund back ASAP. After your event in the Pavilion, you need to return the key to the Village Office either in person between 8 AM and Noon Monday through Friday or by slipping it into the secure slot at the side of the Village Hall. We are offering a ½ price rental rate to non-profits who show 501c proof and also to village groups who help the community. All groups must pay the \$20.00 refundable cleaning/damage deposit. The spacious, clean, **HEATED DOOLEY PARK PAVILION is ACCEPTING RENTALS FOR EVENTS THROUGHOUT THE FALL AND WINTER MONTHS.**

The committee is planning on making repairs and improvements to both the Pavilion and Youth Center. In particular we hope to address some plumbing and electrical issues in the Youth Center and improve air circulation in the Pavilion.

We received some great monetary news this past month. The Village Board approved an increase of the property tax money allocation that goes to Parks for next year. We'll have \$3100.00 which will help us meet our basic bills without dipping into the general fund. Mediacom gave a \$500.00 grant to our parks for use this year. Thank you!

The committee discussed what we need to do to provide a safe fire pit area in Dooley Park. We looked at village ordinances and decided to consult the fire department about safety rules and regulation suggestions. An inquiry has been made to build a horseshoe pit in Dooley Park as an Eagle Scout project. We'll keep you posted on its progress. The Pavilion dumpster has been relocated farther away from the Pavilion for health and aesthetic purposes. Unfortunately people have still been dumping personal garbage into the Parks' dumpster. We ask you respectfully to stop this practice and find another solution that doesn't negatively impact your village.

The Food Pantry continues to meet needs in our community. Last month the Pantry created 40 food boxes and distributed 37 of them. As usual at Thanksgiving and Christmas, food baskets are given to families of TV students in need of help as a part of the Kid to Kid Program. The Food Pantry really appreciates all the generous donations it has received lately. The Downs Topnotchers 4-H Club has taken them on as a project this year. Each month a different 4-H family helps with the Pantry. In addition the club donated \$100.00 to the Pantry which it plans to use for garbage bags and other needed supplies. 4-H Club and the Methodist Church donated a supply of much needed personal hygiene items not available from the food bank. Cub Scouts donated lots of food from their Thanksgiving Food Drive. The Carr family donated 175 lbs of venison, and the Tri-Valley National Honor Society paid for its processing. This provides a nutritious and special addition to the food the Pantry can offer this month. For all of these gifts, the Pantry is truly thankful.

The next Park Committee meeting will be held on Tues., January 26, 2016 at 6:00 PM in the Dooley Park Pavilion. All are welcome to attend.
