Exhibit A

Address to Downs Village Board regarding Mary Goveia

As you know, the board was made aware last week of an affidavit offered by a current board member, Mary Goveia, in a pending legal issue between the village and a developer, Jeff Misch, regarding the completion of Oliver Court in the Farmland Subdivision.

Mary's sworn statement, in favor of the developer and in opposition to the residents of Oliver Court and the Village of Downs, concerns me for a number of reasons.

There are many details in this statement that she had not previously shared with this board, either in open or executive session. Had she done so, we might have acted differently in the action we pursued to seek a resolution to this issue. I believe her omission of this information until now has done the village a disservice.

Additionally, in her sworn statement, she admits to being a part of previous board proceedings where at least one vote was taken and not reflected in the minutes. This would appear to be a violation of section 2.06 of the Open Meetings Act. She also seems to imply consent for the previous practice of "informal action" that should have been voted on, pursuant to Chapter 2, Sec. 9 of the village code, which specifically states that a vote must be taken on "all propositions to create any liability against the village." It also implies disregard for the public's right to proper minutes. It was actions such as these that have put the village in a difficult spot in this case and others.

Last, I consider her siding against the village in this matter at least a conflict of interest and at worst a betrayal of the public trust, particularly her participation in confidential closed sessions despite her ongoing business relationship with the Misches and her apparent intent to testify on their behalf.

I believe that her continued participation on the board puts the Village of Downs at a disadvantage in this matter and damages the board's credibility with the people of Downs. For that reason, I call on Mary to resign her seat immediately. If she is unwilling to do so, then I believe this board should approve a formal censure so that the people of Downs know that we stand with them.
