- 1. The meeting was called to order at 7:00 pm. by Mayor Mike James
- 2. **Roll call** was taken with Trustees Roach, Goveia, Freimann, Myszka, and Lush present. Trustee Luke present at 7:05 pm. Also present were Janice Cuba (Treasurer), Julie James (Clerk) and Dawn Wall (Village Attorney).
- 3. Pledge of Allegiance

- 5. The superintendent's report was given by Kevin Whitehouse and appears later in the flyer.
- 6. The engineer's report was given by Shawn from Farnsworth. He stated that the MFT numbers are under the estimate.

7. Discussion

- a. Parking lot plans for St. Mary's Catholic Church are underway. A 6ft fence bordering neighboring properties is being added. There will be 47 spaces and 2 handicapped spaces.
- b. Beecher Trails Subdivision is being developed by Mark Bowers. The subdivision will be a four phase project of 100 lots. The projected timeline of the project is 10 years.
- c. Down's United Methodist Church was given some direction from the board. A legislative item appears later.
- d. Mayor James would like the board to put together a TIF process packet of information and application for businesses.
- e. Plat changes of Lot 15 and 16 in Indian Hills
- f. Our Golf Cart Ordinance is going to change. The board is requiring the legal age to drive a cart be 18 and have held a license for a year. The new fee of \$50 and inspection will due at the beginning of the calendar year or fiscal year. Seatbelts do not need to be retro fitted. Municipal carts will not need a permit
- g. Trustees Freimann and Lush are going to take on the DCEO Grant Project. The water and street are going to benefit from this grant
- h. The trustees and clerk updated the rest of the board where they were individually on the mandatory training (OMA, FOIA, NIMS, IML). All committees and sub-committees are also required to take the required OMA training.
- i. Village citizens are allowed to voice their concerns with a letter to the board about weeds and grass above 8" through the Abatement/Ordinance violation process.
- j. Currently the two choices left for the Eastside Corridor/Bypass are ½ mile and 1 mile east of Towanda/Barnes. The Downs area connection is set.
- k. The Downs Warning Siren will now only alarm for a natural disaster.
- I. In the future, organizations putting on fireworks display must get a permit from the village i.e. school, churches.
- m. Both the BP and Ups and Downs have applied for video gaming. So the village needs a Video Gaming Application Process.
- n. Other
 - The board wants to draw up a volunteer form to get a pool of resources.
 - A new sign for the front of the Village Hall needs to be installed.
 - The board is going to formalize an application process for any parade in the Village.
