• Beecher Trails

- An annexation agreement with the developer of Beecher Trails is being held off until
 the board decides if the Village decides if they are going to be able to help with
 utilities and easements for water and sewer.
- Kevin Whitehouse, water superintendent, is comfortable with our current water infrastructure to support Beecher Trails.
- The developer wants the Village to get the easements. They need two easements. He
 will eventually pay for it, but initially we will have to carry the debt. We don't have to
 get the easements on the developer's behalf. Farnsworth will review all of their plans
 on our behalf.
- BNWRD has not been approached and could say they do not want to add the sewer connections.
- The Village would need to upgrade ½ of Cedar when the church is annexed in. A traffic study will have to be done to determine the turns.
- Sidewalks will be required to be on one side of the "main" street of the subdivision. The Village in the future may need to look at adding a sidewalk on Huff Rd. as well.
- Beecher Trails has the option of staying in just McLean County.
- The board will send the developer a letter similar to the letter to Downs United Methodist Church, asking them what they are looking for.
- Downs Crossing has four more easements to obtain for water.
- Synder Real Estate may be selling off to Cornbelt the property at Downs Crossing. The Mayor will check with the attorney on if this will affect our REDLEG Grant.

7. Discussion

- a. The board is considering putting a sign under the hall's eave. It was suggested that it say "Village of Downs" across the top and open from the side.
- b. The board is interested in building/purchasing a building to house the streets equipment/police/ and food pantry.
 - The consensus of the board was to use property that the Village already owns on East
 St. Maureen is going to approach Superintendent Simonson about school property
 adjacent to this property. The DCEO grant could be used on this property.
