Public Comment

Indian Hills stop sign

Several citizens were present to express their opinion regarding the stop sign recently installed on Harvey Road. The board passed an ordinance in 2009 approving installation of the stop sign Some citizens feel it's not necessary and will just cause more of a hazard because motorists are not stopping and some have indicated they will run it over.

Lowering the speed limit was suggested as a better resolution to slow people down instead of the sign.

Winter was a concern because the stop sign is on a hill and may cause issues for motorists as well as the school buses.

Opinions were also expressed by the citizens present in support of the stop signs.

The final agreement is still in negotiation, but getting closer.

Donations will be collected and if it's not enough to cover the cost the Village would pay for the additional expenses. The main expense will be for the signs themselves.

Chief Deerwester will now be doing the traffic control at the school between 3:15 and 3:30. The school was contacted about the stop sign on Harvey Road, they are in favor of it but would like the speed limit lowered as well. The bus stops will remain the same.

Building

Everything has been covered earlier in the meeting, nothing further to report

Water/Sewer

208 sewer permits issued and 20 health department permits turned in. still need responses from approximately 160 property owners

Once the September deadline has been reached we need to consider sending out a letter to the property owners that have not complied giving a reasonable amount of time to respond and comply.

Give them 30 days to respond on how they are going to comply.

We will be reasonable for property owners needing an extension.

The only recourse the way the ordinance reads now is to charge with a misdemeanor for ordinance violation

The generator has been tested and reprogramed it will tested again in August.

Hydrant flushing is complete

Water in the wells is in good shape

Design work on the Washington Street is in the works

The sewer at 19 Quail Court was connected and covered up without an inspection being done. A resolution needs to be reached so the sewer can be inspected. The property owner feels he was misinformed by the Village Hall that the inspection had already been signed off on. The easiest resolution is to have the system inspection by camera to try and prevent the whole thing from being dug up. The Village will cover the expense of the camera inspection. If the camera inspection determines there are problems with the system the contractor will have to dig it up and fix the issues. That would be at the expense of the contractor and/ or property owner. If the system passes the inspection, no further action is needed.

Police/Garbage

Sheriff office called about the Egis system which has been approved. After the rehab is done they will be using space in the Hall.

Street Report

Tractor is put on hold, looking into a backhoe instead. Researching price and what would be best for the Village old or new.

Got an estimate on a new one with a lease to buy option, but a new one would give us a warranty. Spray patch is completed

Mowing as needed

Parks/Youth Center

Have events lined up that proceeds will go toward the 4th

The cost of the 4th is getting higher each year and appox \$ 9,000.00 in donations was needed. This year the weather was the issue and dividing between the 3rd and 4th.

Hanson Engineering and members from McLean County Highway Department were present to discuss the plans for the Washington Street reconstruction between Route 150 and Seminary. The property owners along Washington were contacted to get their input. The main thing most property owners would like is a sidewalk on both sides of the road.

The board was asked to let them know what infrastructure improvements they would like or possible trouble spots.

The tile system on the area has caused flooding problems, but is finally under control. A map of the tiles will be given to Hanson and the County so the design plan can account for the tile and water main placement.

The handicapped access will be updated to be in compliance with the current State requirements. Side streets will be graded so they transition smoothly as possible.

Construction estimated to begin late May or June of 2013, they want to work with the school and the Village when it comes to the July 4th activities to make the construction as small of an inconvenience as possible

Will be coordinating with the utilities that will be affected along Washington.

Once the design is complete a public meeting will be held to present the plan and get public input. Hanson and the County will be in constant contact with the Village as issues come up to find out how the board would like to proceed.

There is Fiber Optics to be aware of by the school.
