This is a huge expense to the Village and the only way to pay is to take money from the General Fund. Would like to table this until we can discuss a strategic plan and hear a justification of how the backhoe will be used.

Why is First State Bank being used and not the local bank?

Our local bank could not beat the interest at First State Bank.

We need a new police car and there are potential fees for litigation

This has been talked about many times before. It's a strategic plan with the streets to bring everything back in house and we need the equipment to do it so we don't have to rely on the township and work around their schedule

This is equipment that can be utilized by all committees.

Motion approving discontinuation of fund transfer from SAS Fund to General Fund for part time employee reimbursement by Mike James

Second by Paul Myszka

Maureen Roach abstained

Mike James, Mike Freimann and Paul Myszka voted yes

Motion carried

General fund budgets \$10,000.00 a year for payment of employees. The payroll is paid out of General then reimbursed to SAS Fund

All the part time employees will be paid out of General Fund moving forward This money will be put into a Fund that will be used to fix equipment as needed or can be used to pay off the backhoe early

Motion to approve ordinance 2012-32 approving and adopting amendments to Chapter 19 Sewer Use and Chapter 20 Wastewater Service Charges by Mike Freimann Second by Mike James

Motion carried unanimously

A sunset clause was added in Chapter 19 to set a timeframe for when everyone needs to be connected.

The ordinance shows to the EPA that the intention is to get everyone connected.

Right now there is a BNWRD connation fee but as a Village we are not charging a fee because owners have been paying. If a new property is developed the owner would have to pay the village \$1,000.00 to connect.

Updated the penalty section to cover what can steps will be taken if property owners refuse to connect or are putting something into the sewer that's not allowed

Filing done in Farmland Subdivision and hearing is set next Tuesday

Motion to enter into Executive Session for possible litigation by Mike James Second Mike Freimann Motion carried unanimously

Mayor Report

Video gaming- State of Illinois gives the municipality the ability to approve or deny video gaming with their jurisdiction. The Village gets a portion of the revenue of the games

The quit claim deed for Township property needs to be finalized, need to determine the correct legal description

Washington Street

There is a transit pipe that needs to be replaced east of the school Administration building. Farnsworth was contacted about the design and construction cost to replace the pipe. The expense to replace the pipe could be too small for the IEPA to give a low interest loan. Another option is to do it at the same time Washington Street is redone by the County

The TIF attorney was contacted about extending current TIF boundaries, but a new TIF district would be a better option than extending the current boundaries. There is a process to create a TIF district- the attorneys will be involved in the planning and creating

The advantage is additional revenue and more commercial space. Of course the property owner would have to be in agreement

Building

Received a citizen's complaint about the Old Kickapoo School building. The property owner was contacted to discuss the condition and discussed clearing up the property.

Village hall rehab is underway- almost ready for a permit to be issued.

While we use the office space in the fire station they have asked to not pay for the sewer/water. If the utilities increase dramatically during this time we might be able to consider helping with the utilities or just making a donation to the Fire Department

Water/Sewer

There was a problem with a manhole by the school that has been fixed

Water plant and Sewer lift station is working well

The sidewalks on Cleveland are sinking after sewer construction and need to be addressed 237 permits 219 connections completed

277 have responded in some form

A draft letter to be sent after the deadline. As well as subsequent letter to address people that still do not comply

The permits that came in without a drawing need to be reviewed.

A last reminder will be put in the flyer

Ouail Court issues are not resolved.
