Mayor Cronin turned the time over to Susan Obray, Perry City Recorder to present the 2015 General Election results.

Susan Obray advised that Perry City has 2541 total registered voters. She said that the total percentage vote was 43.41 percent. She stated that there were 1046 ballots that were counted on election night. Susan reported that the percentage counted on election night was 41.16 percent. She added that Perry City was the highest percentage in the County. Susan reported the ballots that were received after November 5th which were timely post marked and counted were 2, and there was 1 ballot that was post marked after November 5th and not counted. She said that there were 10 ballots that were received before November 4th which were marked undeliverable.

Susan reported that there were 47 provisional ballots counted and 3 not counted. She said after counting the valid ballots and provisional ballots, the percentage of ballots counted were 43.41 percent. She stated that 47 provisional ballots are the most Perry City has had historically and that those who voted provisionally will now be registered to vote.

Susan stated that there were 1084 total votes for Proposition 1. She said that for Proposition 1 for the tax were 453 and against the tax were 631, so it failed.

She continued with the votes for the candidates total votes were 3140:
