Minutes of the Salem City Council Meeting held on October 15, 2014 in the Salem City Council Chambers.

Work Session 6:00 p.m.

Chief James reported on the two police vehicles wanting to be surplused.

Rebecca Andrus discussed what Planning and Zoning discussed for the abandoning of the road, and how they put the condition that it would not be abandoned until the other road is completed. She also talked about the Warranty Bond and how the state changed it to 10%, we have been doing that but our code still states 25%, need to change our code to match the state.

Rebecca also talked about the news report about the dog that had died after drinking the water from Utah Lake. The news had portrayed that the lake is poisoned by the waste water being dumped into the lake. This is not true, and the reports are not even sure what the dog died from, they do not think it was the water from the lake.

Rebecca discussed the engineering firms who we have sent out the scope of work on for the transportation and the sewer design work. We are waiting for their reply.

Mayor Brailsford went over the lease agreement for the rental of the home by Rebecca Andrus and her family.

Councilperson Soren Christensen reported we had a leak on the main water line on the Davis property. The leak was reported by a resident to the mayor on Friday and nothing was done to fix it over the weekend, and is just now being repaired. We are trying to figure something out that can be done to fix the problem. The solutions we have tried in the past are not fixing it, the velocity is very high in that area. Mayor Brailsford stated with each leak the dirt is getting washed away so it is leaving rocks behind for the pipe to rub against. There are concerns with having enough water in case of a fire, or getting the water line contaminated. We need to look at replacing the whole line in the area. Attorney Baker stated it might be something we could have the impact fee's help with cost of replacing the line if we need a larger line in there because of growth, it would have to be in the impact fee study though.

Diana Cannell from Allred Jackson CPA firm presented the audit report and financial statement for fiscal year end 2014. Diana is the city's independent auditor. The report will be on the city web page.

#### a. Vacate the Road at 820 South from 100 East to 160 East

We have three bids on the vehicle: Jerry Seiner GMC – 28,610.32, Larry H. Miller - \$24,879. And Tischner Ford - \$23,725. He recommended going with Tischner bid. Mayor Brailsford thought that price was for a two wheel drive and not a four wheel drive, which we would need, especially if we decide to have a snow plow installed. There were also some other questions on the vehicle and which one the parks department recommended, as it was thought the parks department wanted the GMC truck, which is most expensive.

Councilperson Janie Christensen reported we had the State come down and review our sewer lagoons sludge, we are at 16% capacity, which is very good. If it was not for the other mandates from the state our lagoon system could go for a lot longer. We have also met all of the requirements. The sewer department is putting straw in the 3rd lagoon to help with the algae. The collections department is working on replacing the sewer line on Mt. View Drive and Salem Lake Drive. Councilperson Janie Christensen also reported the Star Wars event for the Library will be on November 8, 2014.

#### 15. COUNCILPERSON AARON CLOWARD

Councilperson Aaron Cloward reported the recreation fall leagues are doing play offs and will be coming to an end of the year. The chamber will be doing the Trunk or Treat at South Valley Gym parking lot on October 31 from 4:00 p.m. to 5:00 p.m. The parks

department is working on Pond Town Christmas displays. He also thanked Erman Stone for working at the cemetery, it looked really good this year.

#### 16. COUNCILPERSON SOREN CHRISTENSEN

Councilperson Soren Christensen reported there was another water leak on the Maple Canyon main water line at the Davis Ranch area. We are looking at ways to possibly fix the line in this area. Mayor Brailsford reported we received the invoice from BYU farm for the water usage this year. We used the full amount allotted this year and the invoice for the second half of the year came to \$10,083.
