11. Water and Roads (Nathan Spackman)--Water Conservancy District started taking water last Thursday so they should start paying Deweyville soon.
12. Documentation, Public Info. Ordinance Enforcement (Eric Anderson)--Everyone needs to be careful with fire. March 30 to May 30 is the burn season but you still need to get a burn permit.
13. Park, Walking Trail, Tree Board P&Z, (Joe Kliger)--We might open the park early due to the warm weather.
14. Buildings and Cemetery Maintenance (Todd Bingham)--Byrce and Jim Bunderson entered the meeting and asked if the Deweyville Town would like T posts. The Council agreed that would be nice.
