- 1. Opening Ceremony—Mayor Thayne gave a prayer and led the Pledge of Allegiance.

- 3. Approval of Agenda—Council Member Spackman moved to approve the agenda and Council Member Andersen seconded the motion. All Ayes

4. Approval of March 12, 2015 Council Meeting Minutes—Council Member Spackman approved the March 12, 2015 minutes and Council Member Andersen seconded. All ayes.

5. Proposed Approval of Monthly Bills—Council Member Spackman motioned to approve the bills and Council Member Andersen seconded the motion. All ayes. Bear River Conservancy District will pay us about \$3200 rather than us invoicing them quarterly. There was a discussion of the recycling bin and the costs involved.

6. 2016 Budget Discussion—We will be discussion the tentative budget next month. In June, we will adopt the permanent budget for 2016. The Mayor received a prebid from Grover for about \$20,000 for the Deweyville/Elwood Spring renovation. The Forest Department wants us to grate and lock the road and activate the trough with a trickle float. Hansen told us that we should wait a year so we are not in a drought year. Grover said we should do it now in the dry year and then we will find a permanent water source. Elwood agrees that we should do it now.

7. Planning and Zoning Review—RR35 lots were voted to be ½ acre lots. The Commission is working on other changes and will present it to the Council when they are done.

#### **New Business:**

- 8. Park and Cemetery Discussion--One of the Bear River High School Clubs is going to clean the Deweyville cemetery. Andrew is working on the Park and Mark Taylor will be helping.
- 9. Fire Truck Discussion—The truck is a county vehicle and because of liability issues can only be driven by fire department employees. Mayor Thayne will check on the usage because he thinks the town is insuring the truck. He will also check to see if the town can have a set of keys.
- 10. Arbor Day/ Memorial Day –May 22<sup>nd</sup> will be Arbor Day. Sherie Goring has people coming to plant trees and do cleanup on the walking trail. Bill Kam will speak at Memorial Day. Scouts will present Color Guard and will put flags on veterans graves.
- 11. Street Improvement at the RR crossing—Council Member Spackman cleared up the issue with Mr. Ching. Their data base didn't show Highway 102 as a state road. So Council member Spackman called and they will update their database.
- 12. ISO survey for fire insurance protection—The Fire Chief will do an inspection. That inspection will determine insurance rates. Council Member Andersen will be in charge of getting them any information they need.
- 13. Rindlesbacher's have decided to quit as our town greeters. It was suggested that Kam might be willing to accept the position.

### **Unfinished Business:**

14. Deweyville/Elwood Cold Water Spring Renovation—Council Member Andersen motioned to proceed with the renovation. Council Member Spackman seconded. All ayes.

- 16. Water and Roads (Nathan Spackman)—Council Member Spackman will get Sign Pro to make a slow sign for the Arbon Road. Water is pumping steadily. District is happy. UKON may be able to slow the amount of water they are taking by the end of April.
- 17. Documentation, Public Info. Ordinance Enforcement (Eric Anderson) Residential burn ends May 30. This is going to be a serious fire season. There may be statewide conservation measures.
