1. **Public Hearing** – *Center Street Connection Across the Murdock Canal/Trail*. The City Council will hear public comment and possibly act to approve or deny the Center Street connection across the Murdock Canal/Trail. 2. **Public Hearing** – *LCC Chapter 18.03 “Definitions & Regulations” and LCC Chapter 18.04 “Billboard Advertising”*. This is a request for approval by Terry Reid for an ordinance amendment to allow digital face changes on off-premise signs, specifically billboards. Recommendations by the Planning Commission have been forwarded to the City Council for approval. - 15 minutes
