**CURRENT BUSINESS**

1. **Public Hearing** – *Fireworks Restrictions (Resolution #2013-2-R)*. This is a continued request by Chief Cody Cullimore for the City Council’s formal action to review and possibly act to approve a resolution establishing a restriction on the use of fireworks in specific areas of the city. Per the Council’s request, additional noticing of impacted properties to seek public comments within the proposed restriction area has occurred. - 30 minutes
2. **Discussion Item** – *Hiring Policies for Aquatics Center*. This is a request by staff to have the Council discuss and provide feedback on hiring 15-year old lifeguards for the Lindon Aquatic Center. Heath Bateman, Parks & Recreation Director, will lead this discussion. No motions will be made on this item. - 20 minutes
3. **Discussion Item** – *Elected & Appointed Officials Compensation Policies*. This is a request by staff to have the Council discuss and provided feedback concerning a possible ordinance change to identify compensation policies for electronic equipment required for elected or appointed officials to participate in public meetings and other normal activities within the scope of their duties.
