If you're doing a lot line adjustment you don't need to do a 28 boundary line adjustment. 29 R Sneddon said the 15 foot minimum width to get the common boundary can be done some other way. 30 G Allred talked about the B-2 case. You can do a boundary line adjustment however you want to. 31 S Bankhead said if there are 2 recorded lots and you want to put them together as one that is still consolidation. 32 S Bankhead will check on combining the tax ID numbers for the next meeting. 33 G Walker is not on board with the method and way we're trying to make people consolidate lots. 34 S Bankhead said if the Commission wants to see the lots before they're consolidated they have to put that into the 35 36 G Allred wonders how much burden that will put on other Commissions if we require that. 37 J Baldwin wants to add 11-3-8:D. Final Consolidation Status- The final lot consolidation must be approved by the 38 Planning Commission and is not considered effective until one tax ID number has been issued by the County. 39 S Bankhead said if you want to keep the foot path theory then you don't have to do anything to the ordinance. 40 R Sneddon said there still has to be a minimum width. 41 G Walker asked if the connector lot has to have its own tax ID number. 42 S Bankhead said she will bring 2 proposals to the next meeting. 43 S Eames wants to know how the Commission feels about the barbell lot. 44 G Walker feels like the Commission should address the use not the lot shape. 45 Yea: R Sneddon, J Baldwin, R Cecil, G Allred, G Walker 46 Nay: None 47 Abstain: None 48 **Excused: None** 49

## STUDY ITEMS:

Item No. 1: The Providence City Planning Commission will consider amending the Providence City Use Chart to allow cell towers as a conditional use.

52 53 R Sneddon read some requirements from the fact sheet handed out. There are 3 distinct sources of service. This is not a

54 simple subject. He read from a table listing on cellular, broadband and SMR. 55

G Walker said when the requirements of the conditional use permit are compliant with the regulations articulated by the 56 FCC for the specific use.

- R Sneddon said not in a residential area, it can't look like an antenna.
- G Walker said put them in the CHD district.
- 1234567 Mike Tycser said cellular has to abide by the FCC rules. Secondly, you put these on 60-70 foot towers. It is thermal
- heat. You can't deny the towers because of health issues.
- G Walker said someone is going to benefit from the towers. We have to allow them somewhere.
- S Bankhead said in CHD there are restrictions.
  - Chris Memmott with Rocky Mountain Telecom said there is a place in the CHD district that we are looking at. It is
- located on the property behind LeGrand Johnson in the movie theatre parking lot.
- 89 C Memmott and M Tycer explained how they find the locations for the towers. There goal is to answer questions and
- 10 help the Commission understand the benefits that a tower can bring to the City. FCC requires that the towers are
- 11 maintained and safe. They both will be glad to be here and discuss this issue with the public.
- 12 R Cecil asked how big a tower and how many units on it.
- 13 C Memmott said 120 feet and 3 or 4 units on it. He explained how the cell site works. The more customers you have the
- 14 less coverage you have. There are all kinds of applications for cell sites that can work.
- 15 C Memmott explained the differences between SMR, broadband and cellular.
- 16 R Call asked how many towers are in Logan.
- 17 M Tycer said he believes in all of Cache Valley there are about 20-25 towers.
- 18 R Call asked how high they could go.
- 19 C Memmott said 150 feet.
- 20 R Call asked what the timing is.
- 21 C Memmett said they would like to build tomorrow.
- $\tilde{2}\tilde{2}$ R Sneddon asked why Providence has to have 120 foot tower.
- 23 C Memmott said Providence only needs one and it's safer.
- 24 C Memmott discussed the size of the base area.
- 25 This will be brought back to the next meeting.
  - Item No. 2: The Providence City Planning Commission will discuss light manufacturing.
- 27 28 R Sneddon suggested adding impacts to the use.
- 29 G Walker asked if we cared if it is in CGD.
- 30 J Baldwin suggested not allowing light manufacturing in residential. Change the impacts to Home Business Use.
- 31 G Walker said add a home business must be low impact.
- 32 The Commission went through the additions to the ordinance.
- 33 S Bankhead said you can mitigate through the conditional use. If this definition is to liberal the home business impact 34 needs to be looked at.
- 35 R Sneddon wants to talk about Light Manufacturing in the Commercial District.
- 36 R Blossom said right now you can't do light manufacturing in the commercial district and it needs to be allowed.
- 37 D Calderwood asked if there is anywhere to put in an industrial zone.
- 38 S Bankhead said traditionally industrial zones take up big chunks of ground. The City shied away from an industrial
- 39 manufacturing area. Light Manufacturing is a friendly business for CGD.
- 40 R Call said light manufacturing and industrial create jobs.
- 41 D Calderwood said he has a hard time telling someone they can't put in light manufacturing in with professional
- 42 businesses. CHD has been set aside for sells tax producing businesses.
- 43 S Bankhead believes there are places in Providence that would work well for an industrial zone.
- 44 R Sneddon wants light manufacturing brought back next week to look at CGD.
