Item No. 2. Ordinance No 001-2013. The Providence City Council will consider for adoption an ordinance amending Providence City Code Title 10 Zoning Regulations, Chapter 1 General Provisions, Section 4 Definitions including but not limited to Accessory Buildings, Main Buildings and Business Use General, Low Impact and Medium Impact.

Item No. 3. Ordinance 002-2013. The Providence City Council will consider for adoption an ordinance amending Providence City Code Title 3 Business and License Regulations Chapter 1 General License Provisions amending the payment dates and late penalties.

Item No. 4. Ordinance 003-2013. The Providence City Council will consider for adoption an ordinance amending Providence City Code Title 7 Public Ways and Property, Chapter 1 Streets, Sidewalks, and Public Ways regarding snow removal.

Item No. 5. Ordinance 004-2013. The Providence City Council will consider for adoption an ordinance amending Providence City Code Title 7 Public Ways and Property, Chapter 7 Parks and City Owned Buildings by adding Section 9 Special Events.


Executive Session:
