- Mayor Bybee's Tribute To Brent Stuart
- Brent started working for the City on October 29, 2002, as the Building Inspector. He has worked for three Mayors, Craig Kendell, Mike Keyes, and myself. Brent started when building was going strong doing 33 building permits his first year and ending when building was at its lowest with eight permits. All in all he handled 186 building permits, reviewed many plans, and worked hard to help homeowners interpret and comply with Uintah's zoning and code ordinances. He did all of this in the 12 years that he has worked for the City.

15. DISCUSSION/ACTION ON INTERLOCAL COOPERATION AGREEMENT BETWEEN WASHINGTON TERRACE AND THE CITY OF UINTAH FOR BUILDING PERMIT, PLAN REVIEW, AND INSPECTION SERVICES: (01:13:59)

Presenter: Mayor Bybee

- Mayor Bybee explained that with Brent Stuart moving on to other things we have decided to enter into an Interlocal
 agreement with Washington Terrace to use their building inspector.
- Jeff Monroe does both commercial and residential inspections; he is close working between Washington Terrace and South Weber as their Mayor.
- Entering into this Interlocal will take care of a lot of the issues the City has been experiencing.
- There were no other questions.

16. DISCUSSION/APPROVAL ON FIRE STATION DESIGN: (01:37:36)

Presenter: Shane Sanders

- Mayor Bybee explained that Mike and Shane Sanders are here to present the Fire Station Design Proposal.
- The Fire Station Design was done under a grant that was applied for when Craig Kendell was Mayor.
- Mike and Shane Sanders have worked with the Fire Chief and others to come up with a design that was funded under the grant.
- When the project under the Grant was started, there were several steps along the way which required approval. All
 of those steps have been completed.
- Tonight is the presentation of the work that was done under that grant.
- That means that this is a presentation, not a vote.
- Let me say, this is not a presentation to build; it is a presentation to present a proposed design.
- There is no funding to construct a fire station.
- Shane Sanders reviewed and presented the site plans to the Council. He explained that it is ready to go to bid.
- The floor plan and elevation plans were reviewed.
- Shane explained that this design would bring us up to code for an essential facility.
- He explained that the survey found some problems. The road needs to be dedicated to the City and the zoning is residential.

- Dave and Don both thanked Mike and Shane for all their efforts on this project.
- Gordon Cutler stated that he had sticker shock and asked if this was just a cost estimate. Shane explained that a lot of the estimate was for a metal building and bringing the existing building up to code. Gordon stated that this is a lot of money for our town.
- Shane explained that as you are building you can always take out some of the upgrades.
- · Mayor Bybee explained the next step is to form a committee and assess what we want to do and work on the fundir
- Heidi Flitton asked if this was the final design and if the grant is finished; Mayor Bybee that this is the final design and
 the grant is done.
- Shane stated that they did what was best for the City. This satisfies the wants of the Fire Chief and the expansion plans.
- Mayor Bybee stated that this is an essential building and that we need to bring it up to code.
- Mayor Bybee thanked Mike and Shane for their time and work on this project.

17. DISCUSSION/ACTION ON WEBER COUNTY LIBRARY 5 YEAR CAPITAL IMPROVEMENT PLAN: (00:33:37)

Presenter: Kevin Wilson and Karen Burton

- Kevin Wilson explained the facts behind the special Weber County Bond Election.
- Why:
 - o Library us as at an all-time high and increasing every year.
 - o The Main Library, built in 1968, has significant structural and mechanical problems.
 - o Southwest Branch is too small and is inadequate to meet the demands of a growing population.
 - o Land has been provided by Roy City for a new Southwest Branch.
 - North Branch is too small to serve northern Weber County, and has unfinished space that can double the size available to the public.
 - With expanding parking, Ogden Valley Branch can accommodate large groups and serve as a community center.
 - o The cost of borrowing money for construction is historically low, but will increase in the future.
 - Library funds are increasing being used to repair buildings instead of enhancing library facilities or programs.
- What:

- o Replace the Southwest Branch with a larger, modern library constructed on donated land.
- Renovate and upgrade the historic Main Library.
- o Modernize and double the space of the North Branch.
- o Add safe, street parking at Ogden Valley Branch.
- How:
 - Bonds will finance the renovation and upgrade of the Main Library, a new Southwest Branch, doubling the space for the North Branch, and expanding parking for Ogden Valley Branch.
 - o All for the average cost of \$2.63 per month for a \$161,000 residence or \$4.06 per month on a business property with the same value.

- The issuance, denial, modification, revocation and enforcement of UPDES permits, including general permits,
 Federal facilities permits, and sludge permits; and approval and enforcement authority for the pretreatment program.
- The Interlocal cooperation agreement is with the Weber County Coalition. The Coalition works together to pool resources so the cities and county can accomplish some of the requirements that are reported each year under our MS4 permit (municipal separate storm sewer systems).

- Don Pearson We completed the 6600 Cemetery Road crossing and should have the crossing arms for 2275 E in June.
- Heidi Flitton This Thursday is our U-Day meeting, we have lots of work to get done. The Fire Station design is beautiful; we still have a lot of work to do before we build.
- Gordon Cutler Thanked Don for all his work and relations with the railroad. He thanked Jerry for all his efforts with the U-Day salmon bake and echoed what Heidi said about the Fire Station and all the work that still needs to get done.
- Mayor Bybee Public Comments The City Council has been discussing the suggestion to move the Public Comment to the beginning of the meeting.
- The public comment period is generally not a time for dialogue between the council and the public.
- The type of meeting governs the type of public comment a citizen may make.
 - Regular Session, like tonight, Citizens are permitted to address the Council concerning any matter over which the Council has jurisdiction, including comments concerning an item on the agenda. Comments needing or requesting follow-up will be assigned to staff for further action as appropriate after the meeting
 - The other type is Public Hearings. Public Hearings are more structured and comments are taken on specific topics. Some public hearings are subject to special rules imposed by state law or a particular ordinance.
- As a reminder, the council is available after City Council meetings to discuss concerns or questions with individuals
 or you can always contact them.
- We will move the public comments to the beginning of the meeting.
- Don Pearson commented that he would like the public to contact him prior to the meetings to discuss any of the agenda items; either by email, phone or in person.
- Mayor Bybee explained that's when we need the comments while we are working on the issues not just prior to the
 meeting; it's not effective that way.

22. PUBLIC COMMENT (2 minutes per person): (02:10:42)

- John Allen "The comment period, it's a great thing, to help us facilitate asking the questions. Can we have this council packet available when you guys get it because I look at the agenda items and I have no idea what this means. I know a couple of the agreements; I don't know what all this is without more information. I was just following up with what you were just talking about having the comments sooner because you get the packets on the weekends. If we had the same information at the same time we would have the appropriate questions for you at that time. Because at the beginning or the end of the meeting people are clueless on the agenda items unless we have contacted you personally. It is great, it's just that if I contact Don about the railroad and ask him I know but nobody else knows. One on one is great but it doesn't get the information out to everybody. Because, you know, there are a lot of people who are not here and should be at this meeting. I shouldn't have to do this, the people should be here to make comments but those people are not here for whatever reasons could not be here, they could have more information if we have the council packet. Thank you."
- Michelle Roberts- "This is obviously my first council meeting so I don't know how this works, this is not a question and answer time? I just want to say that on the topics page you posted about the kitchen, I really appreciate that. I didn't know about all the people that have donated time and efforts until Heidi explained that to me last week and I just think it is great that we have so many volunteers that will donate their time to the city. And so I read that and I appreciate that. The fire station, he kept pointing out and comparing to Ogden City, and I just feel like you can't compare us to Ogden City because they have full time employees and we don't. I know that there needs to be things done to the fire station and what not, that was my only comment and also I didn't realize how much work you guys put in. You talk about the storm drains and the railroad crossings and all the things you guys do. I am really enlightened tonight and appreciate you guys."
