Presenter: Sheriff Thompson

- Sheriff's Thompson stated that he appreciated all the hard work that Lt. Burns, Lane Findlay and Clint Anderson do for the Department.
- He stated that they are trying to improve the communications between the Sheriff's Office and the municipalities' that they serve. They want the leaders to know what is going on in their cities.
- They had a meeting with the Mayor's to see what was needed; and the Mayor's invited them out to visit and report.
- Sheriff Thompson introduced Lane Findlay to present the presentation.
- Lane Findlay stated that they were going to try to improve communications by reporting to the City on a quarterly basis.
- He reviewed the prior quarter's calls for service; reports; citations and five year comparison.

- He stated that they had 24 calls at the Natural Rock Design; this is a problem spot.
- He reported that we have no significant crime patterns detected and that the overall crime and property rates are down.
- The total citations for 2012 were 316.
- They are going to be proactive with prevention; they plan to visit schools; have bike patrol and do premises checks.
- Lane Findlay asked the Council for questions.
- Heidi Flitton stated that we are getting less with less; yet are paying more.
- Lane Findlay stated that we had to cut the CRO positions due to budget cuts, we have no more manpower.
- Mayor Bybee thanked them and stated that they are doing a great job; it's just the cost to the City. We don't have that kind of money; our revenues are down; citations are down; we appreciate all that you do.
- Sheriff Thompson stated that they have trimmed their budget by \$1,000,000 and that was in personnel; he prefaced that they have cut positions off the books; the command staff has been reduced and they are also facing the URS increases.
- He stated that they will have the information to the Cities in July for the FY 2014-2015 and there should not be a big increase.
- Gordon Cutler stated that he appreciated Lt. Ferrin and the great job he was doing with animal control; Heidi Flitton echoed that.
- Mayor Bybee thanked the Sheriff and his staff for their time and presentation to the City.
