**A RESOLUTION OF THE BOARD OF TRUSTEES OF THE TOWN OF
HOT SULPHUR SPRINGS, COLORADO, ACTING AS THE LOCAL
LIQUOR LICENSING AUTHORITY, RATIFYING THE APPROVAL OF
THE RENEWAL OF THE HOTEL AND RESTAURANT LIQUOR
LICENSE FOR SW PROPERTIES LLC D/B/A BARKING DOG PUB**

WHEREAS, SW Properties LLC d/b/a Barking Dog Pub is the holder of a Hotel and Restaurant Liquor License that expired on October 21, 2012 ("License"); and

WHEREAS, SW Properties LLC d/b/a Barking Dog Pub made application for renewal of the License on October 30, 2012; and

WHEREAS, Section 3-3-1(B) of the Town Code authorizes the Town Clerk to administratively renew and approve renewal applications when the application and fees are timely submitted, the license is in good standing with the Town and the State, and there is no knowledge of any criminal or legal investigation of charges against the licensed premises; and

WHEREAS, although the application for renewal was received after the License expiration date, Colorado law permits a ninety day period in which an applicant may seek renewal before a license is deemed abandoned; and

WHEREAS, the Town Clerk, upon receipt of the completed application and applicable fees, including the late fees, and upon investigation which revealed that the License is in good standing with the Town and the State and there is no knowledge of any criminal or legal investigation of charges against the licensed premises, approved the renewal on October 30, 2012, in order to allow the licensee to restart operations selling and serving alcoholic beverages without need to wait for the Town Board of Trustees meeting scheduled for November 15, 2012; and

WHEREAS, the Town Board wishes to adopt this resolution ratifying the action of the Town Clerk and approving the renewal of the License effective as of October 30, 2012.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE TOWN OF HOT SULPHUR SPRINGS, COLORADO, ACTING AS THE LOCAL LIQUOR LICENSING AUTHORITY:

Section 1. The Board of Trustees acting as the Local Liquor Licensing Authority for the Town of Hot Sulphur Springs hereby ratifies the action of the Town Clerk and approves the renewal of the License effective as of October 30, 2012, for SW Properties LLC d/b/a Barking Dog Pub, 517 Byers Avenue, #3, Hot Sulphur Springs, CO 80451.

Section 2. If any section, paragraph, clause or provision of this Resolution shall for any reason be held to be invalid or unenforceable, the invalidity or unenforceability of such section, paragraph, clause or provision shall not affect any of the remaining issues of this Resolution.

Section 3. This Resolution shall be effective immediately upon approval of the Board of Trustees acting as the Local Liquor Licensing Authority for the Town of Hot Sulphur Springs.
