A RESOLUTION CANCELLING THE REGULAR ELECTION SET FOR APRIL 1ST, 2008 AND DECLARING CANDIDATES WHO FILED NOMINATION PETITIONS ELECTED ACCORDING TO C.R.S. 1973, 21-10-507.

WHEREAS, the Board of Trustees of the Town of Hot Sulphur Springs has passed Ordinance #268 allowing for cancellation of the election according to C.R.S. 1973, 31-10-507.


AND, WHEREAS, it now appears that the only matter before the voters is the election of persons to office and there are not more candidates that offices to be filled at such election, including candidates filing affidavits of intent, and the Clerk hereby certified such facts to the governing body.

A RESOLUTION OF THE BOARD OF TRUSTEES APPOINTING
