- 1. The meeting was called to order at 6:00 pm.
- 2. The Pledge of Allegiance was led by Mayor Moser.
- 3. Roll Call: Trevor Black, Roger Ashmore, Dale Kingsley, Kevin Sair, and Mayor Moser were present. Legal Counsel was excused. Code Enforcement Officer, April Ruesch was present. Town Clerk Nathan Bronemann took minutes.

5. Public Comments

Margaret Ososki asked it Ted Gubler's old house was the equipment storage location for Desert Rose.

Mayor Moser said that he was unaware of that.

Dick Naylor asked if Ted Gubler's old house was part of the Gooseberry Subdivision.

Mayor Moser said that he was unsure. He said that he would look into it.

Margaret Ososki asked if someone could explain the process of annexation to inform people before the Town meeting.

Mayor Moser said that is something they would take into consideration. He said that the Town was waiting to make sure of the final election date before they acted on anything.

Mike Maddocks said that there was a new gate that had been put on the back side of the Gooseberry Subdivision.

Mayor Moser said that he had spoken with the LDS church and that he would be obtaining a key to that gate for the Town.

Mike Maddocks asked if absentee ballot would be made available for the disincorporation election.

Mayor Moser said that they were still trying to figure out the details and that the Town would announce that information as soon as it was decided.

Doug Randall said that the Town would do a whole lot better if everyone would help out.

Mayor Moser said that the water right could be moved down to Apple Valley proper and would still be of use to the Town.

9. Discussion and action on setting a work meeting to discuss the Town budget

Mayor Moser said that the Town Council needed to need to review next fiscal year's budget. He said that Chief Bass would need to attend to represent the fire department.

Motion made by Roger Ashmore to schedule the budget work meeting for May 2nd at 7:00. Kevin Sair seconded the motion. Vote: Trevor Black-yes, Roger Ashmore –yes, Dale Kingsley-yes, Kevin Sair-yes, and Mayor Moser-yes. The motion passed 5/0.

10. Report and recommendation from the Planning Commission

Mayor Moser said that they were still working on revising ordinances.

11. Report and recommendation from the Big Plains Water and Sewer SSD

Denny Bass said that they were still waiting for the final purchase contract.

12. Report and recommendation from the Parks and Recreation Department

Marcia Miner reported that after showing the park plans to Home Depot will fund 80% of the pavilion, splash pad, and the rest rooms. She also said that Schultzens was going to donate fencing and that the sod was going to be anonymously donated. She said that she was waiting for a groundbreaking date from Town Council. She said that the volunteer day had been set for June 9th.

She announced that the Independence Day breakfast was the next Town event to take place after the Chili Cook-off this Saturday. She said that she needed nominations for the Grand Marshall for the Founders Day parade. She also said that she would have the park plans posted

so that everyone could see them. She showed the playground equipment that was planned to put in. She also said that there would be a yard sale held in June at the Chevron to benefit the park.

Marcia Miner presented the park plans. She said that they were still looking for donations for excavation and water and electrical installation.

Marcia Miner said that as soon as they got an excavator lined up they would set a groundbreaking date.
