Liability Waiver and Guidelines

The undersigned, on behalf of myself, my spouse, my agents, all minor children over whom I have custody, control or responsibility and all other persons or entities who use the Annabella Town Community Center and facilities pursuant to permission requested and/or obtained by me by this application, hereby waive and release from injuries, death or property damage sustained while using or being present at, in, or on the Annabella Town Community Center and facilities; except such injuries, death or damages caused by latent defects on the property of which Annabella Town is away are fails to give warning.

The undersigned on behalf of the same persons or entities further covenants to not sue Annabella Town for any reason arising out of use of the Annabella Town Community Center and facilities.

Furthermore, I am aware that exercise can be physically stressful and in certain instances can even be harmful and result in death. I understand that I should consult with my personal physician before I begin any exercise program.

I certify that I am at least eighteen (18) years of age, medically sound, and physically fit to participate in physical activities. I further certify that no oral promise, agreement, warranty or representation concerning safety or liability of the Annabella community Center or its equipment has been made to me. I certify that I have read the foregoing information and understand it and any questions, which may have occurred to me, have been answered to my satisfaction.

By signing this form, I also take responsibility for damages to the Annabella Community Center or its equipment from anyone accessing the building with my key.

Furthermore, I acknowledge and agree that the minimum age requirement for the exercise room is 14 years old. Youth under the age of 14 may not, under any circumstances, enter the exercise room. Youth under 14 may use the basketball room if they are accompanied by an adult (at least 18 years old).

I have read the Annabella Community Center liability waiver and guidelines. I understand that I must follow all facility guidelines of the Annabella Community Center and facilities. If I do not, I may lose permission to use the building.
