Rental Rules and Regulations

As a Qualified Sailboat Operator I Agree:

1. to register MYSELF and ALL MY GUESTS with BONNEVILLE SAILING and warrant that each participant has properly executed a current waiver agreement prior to using any vessels or facilities. I assume all risks and responsibilities for each participant in my party, including those who fail to provide a signed waiver. I hold harmless Bonneville School of Sailing and its personnel for all risks and will defend such in any actions that result from my captancy or for my failure to provide a properly executed waiver for each of my guests.

2. that prior to departure I will consult with Bonneville Sailing authorized personnel if I have any doubts about my abilities to operate Bonneville's vessels, the weather, or my understanding of safety or operational procedures. I will immediately seek safe harbor or assistance when conditions warrant.

3. that I am fully and solely responsible for the safety of myself and my guests at all times, including the legal operation of vessels under my command. I further warrant that my guests are fully capable of safe participation. I understand and will comply with all State rules regarding the safe operation of vessels under sail or power. I hold harmless Bonneville School of Sailing and its employees for my actions with any vessels or equipment, and will fully defend each in such regard.

4. that each reservation for sailing time constitutes a binding payment agreement, guaranteed by my valid credit/debit card. I hereby authorize for payment, without qualification, all charges associated with my reservation and use of vessels and equipment, including, but not limited to, cancellations and extraneous charges for cleaning, loss, damage, late returns, rule violations and rescue.

5. I agree to pay, and authorize credit card charges of \$50/hr, for any extraordinary clean-ups, including, but are not limited to: dark shoe marks, illness, and rubbish removal.

6. that I will secure any vessel under my command to docks at sunset. Except in an emergency I will not dock vessels at any other location at any time. I will immediately and fully apprise Bonneville School of Sailing of my situation and the vessel's condition and location whenever an emergency situation arises.

7. that I am financially responsible for all damages or loss to vessels and equipment under my command. I am additionally responsible for all damage to any other persons, vessels and equipment that result from my actions or omissions. I authorize, without reservation or revocation, my credit card provider to approve charges for any such losses that are the result of my operation of Bonneville's vessels and equipment, including but not limited to, misuse, recklessness, and negligence. I agree to report any incidents, damage and/or unsafe conditions immediately.

8. that I will not operate Bonneville Sailing vessels under the influence of drugs or alcohol. I accept full legal and monetary responsibility for any injuries, fines and damage that result from my operating the vessel while impaired, including those necessary to release an impounded vessel.

9. that I understand and will comply with engine operation and propulsion procedures under both sail and power. I will be responsible for insuring that I have adequate fuel for my activities, including safe return to docks. I understand and will always comply with Bonneville's rules regarding safe sail deployment, especially as weather changes and when entering and exiting the harbor.

10. to insure that all in my party will wear weather-appropriate clothing, soft-soled, non-marking shoes, sun protection and PFD's when warranted.

11. that I will, at all underway times, possess and maintain a serviceable cell phone in a waterproof container, reliably operational for a distance no less than the vessel's expected sailing radius and sailing duration. Prior to each departure I will inform Bonneville of this phone's number and will monitor this phone for emergency communications at all times. I will immediately contact Bonneville School of Sailing when threatening situations develop, identifying myself, alerting them to my situation, my position and my intentions.
