**RULES & REGULATIONS:**

I agree to sell only that merchandise which is shown in the photographs and listed in the description included in this application. I understand that submitting an application does not guarantee me space in Lindon Days. All merchandise sold must have been represented in the photographs submitted to the jury. All products must be approved by the jury selected by the Lindon Days committee. Lindon Days reserves the right to disallow any item that is not in keeping with the standards of Lindon Days. I am aware if I sell any items not included in my application a member of the Lindon Days committee will ask me to remove those items from my booth.

10' x 10' non-food booth fee is \$100.00. 10' x 10' food booth fee is \$150.00. Booth fees due upon acceptance into Lindon Days.. No booth fee refund for a cancelation after July 31, 2011. All accepted vendors will be advertised in the Lindon Days mailer under the vendor list free of charge if application and payment of fees is received by June 1, 2011. Vendors can place a color add in the mailer for an additional charge.

A booth space is an uncovered 10' deep x 10' wide space on the grass. Electricity is available for food vendors only. Vendors are required to provide their own booth structure, tarps, tables, chairs, etc. Displays must be confined to the booth space, and not encroach on the walkways or the spaces to the side or rear of the booth. Booth spaces are assigned randomly. Assignments

must be adhered to and are not transferable. All sales must take place from your assigned booth and not from vehicles, trailers or campers. No roving sales are permitted. Food vendors may sell out of an approved food trailer. Each vendor will be assigned a set-up time that must be honored.

Vendors are required to be in their booths from 11:00 am to 8:00 pm Friday and Saturday.

Vendors are to comply with the Utah State Tax regulations. The Tax Commission will provide tax packets for each vendor.

Lindon Days is not dependent on weather. Fees will not be refunded in the event of rain or winds. Each vendor is responsible for any damages to, or from, your booth and/or product.

Material deemed controversial by the Lindon Days Chairman or the Lindon Days Committee will not be allowed in the fair. A booth may be pulled from the fair as late as the day of the fair if, in the judgment of the chairman or members of the committee, the entry is deemed controversial, unlawful, or unsafe in any manner, or is otherwise inconsistent with the standards, theme, quality or purpose of the Lindon Days Fair.

Booths promoting or opposing candidates for political office or political issues are not permitted as part of the fair.
