# MEETING MINUTES OCTOBER 6, 2011

## **Engineer Report**

Interstate 74 bore is done, Fischer is finalizing Phase C. Stark is starting the clean up at the park. Seeders are scheduled to be in next week. Spray patching to fix the trenches will begin on Friday.

Spot check done at Mallard, the pipe is pretty dirty and needs to be cleaned out. It's mostly sand. Once it's turned into sanitary the problem will be resolved. In general for a system that's 15 years old it's on par. Some property owners might want to cut into the pipe instead of using the T that is already there. Allowing that would be a decision for the board. As long as done properly it won't cause any issues, the old T will need to be capped.

There is a change order and final pay request for Phase C- just balancing out the final pay request. Phase C is under budget. Final bill will be submitted to IEPA for payment that will be turned over to Stark in exchange for the final lien waivers. The one year warranty will begin on the completion of construction. Seeding of Kickapoo Park will need to be redone after the pipe is done.

## **Public Comment**

Village Market has concluded another successful year. Next year is 10<sup>th</sup> anniversary the committee is making special plans. Would like to add a tree at the entrance and move the sign around the tree with some landscaping.

A petition was presented by homeowners in Farmland Subdivision requesting the roads be completed. They would like an estimated date of when the roads will be complete. Whether TIF funds can be used to complete the roads was questioned.

There has been vandalism on the playground equipment again. A police report has been filed and if the individuals are caught will be prosecuted.

Playground equipment, gazebo and picnic tables were all damaged.

#### Discussion

The temporary road was to be put in only until the sewer construction was complete. It's on village property and the Village attorney advises not to allow it to stay. Prairie woodworking would like for it to stay. It doesn't mean we cannot do something to make it a permanent road. Lincoln Street extended would connect to Shaffer and do the same thing. It would be a village road that we would maintain Jeff Misch

The road was temporary, but it's been beneficial. Woodworkers don't want the Lincoln extension because their trucks will not be able to turn around and maneuvered easily like they can now.

Asking for an alternative to Lincoln extended to be investigated before making a decision.

What would be the next step for extending Lincoln Street?

Most of the preparing is in the works- maybe next year.

Had citizens complain about the Lincoln extended but if the temporary road was made permanent it would be more advantageous for the businesses.

A cost comparison will be done to determine which option would be most feasibly -Lincoln Street extended or making the temporary road permanent.

There was an agreement with several extensions. The Farmland roads were agreed to be done when sewer construction was complete

Homeowners have been told the roads will be done when all the lots were built on.

If we have the agreement- can TIF money be used for this? If there was TIF money to be given it should have been in the agreement. The original agreement needs to be located.

Red water filter has been dug out and the materials are all new.

Need to work on reconstruction in the yard. There is a cracked sidewalk that also needs to be fixed.

## Sewer

Had a meeting with BNWRD to go over a portion of the ordinance. BNWRD would like to approve any changes prior the ordinance being revised. BNWRD does not care about what goes on in town- they want to make sure what is in the flow to them meets their standards. The ordinance will be revised and hopefully ready to approve next month. BNWRD will not take care of having the fee added to the real estate tax bills. This is something the attorneys will need to work out. If it's not added to the bills it would be a huge burden to the Village.
