a. Snow removal – costs, complaints

Salt needed on the corner of Washington and Seminary next to Methodist Church very slick from water run off from the Church.

Village will re-bid snow removal for 2011 and define snow removal for village worker.

All (4x6) wood not installed with 6" side facing traffic then the post needs holes drilled in them to weaken the post in case of accidents.
