MEETING MINUTES DECEMBER 1, 2011

Public Comment

Ken Bays presented documents for the Board to review concerning the roads in Farmland Subdivision and whether they are private or public roads.

Several other property owners in Farmland Subdivision expressed their concern that the road has not been completed and would like to know what steps are going to be taken to insure the road will be completed and who's responsibility it will be.

The proposed Resolution for completion was read to all present so the property owners know there is a time-line that will be in place for the Developer to complete the road if the Resolution is passed.

The Resolution simply states that the Developer still owns the road because it has not been accepted by the Village of Downs, therefore it is still responsibility of the Developer. In order for the road to be the responsibility of the Village it would have been previously accepted by the Village and there is no record of that occurring.

The Road is dedicated for Public use, but not accepted by the Village to maintain

Motion to approve Resolution 2011-20 approving the deadline of completion of Farmland Subdivision road by Developer by Mike Freimann Second by Mike James

Discussion

The previous administration was going to try and get the expense of completing the road covered by either TIF or Motor Fuel funds. The Developer was asked not to complete the road prior to sewer construction. Allot of this is verbal but it does not seem like we are treating the Developer in a proper manner. Yes ,the Developer is responsible for the road but there should have been more discussion prior to this resolution being brought before the board for vote . The Village needs to talk to the TIF attorney to find out if funds can be used.

From a legal standpoint this municipality does not have the authority to grant TIF funds that are not bartered for. This should have been negotiated with the original development agreement. The original agreement cannot be located so the Ordinance is what the Village needs to enforce. As a municipal authority you cannot create new agreements for old deals. If you create a redevelopment agreement after the development is done you open yourself up to any prior developer to coming back to try and renegotiate.

We need to follow the Ordinance to service the citizens of the community

What if someone hires a contractor how do they find the T? –Either by looking at the as-builts or there should be a 2x4 in the yard where the T is.

Need to address vandalism at the lift station- already have had vandalism

Pre-annexation

Need to consider a notice to BNWRD that we want to recend the original agreement.

Need to have pre-annexation agreement with BNWRD- BNWRD will approve it then we will ratify it. One consideration is anyone who does not join now will have to pay for the hook up-people outside the current area- like a subdivision that wants to use the sewer

Draft Letter to homeowners to review and give suggestions prior to sending out. The letter is step by step of what is going to happen and how to go about hooking up. All Commercial property will go through BNWRD directly

Chapter 20 and the usage calculation spreadsheet

If a property owner has a working system they are not required to hook up but will still have to pay the usage

A resident from Farmland Subdivision asked the question-

Is TIF money being spent for sewer construction outside the TIF area?

The pipe that goes to Downs Crossing is being paid for by TIF funds which is allowed because it's providing the service to Downs Crossing
