\* The Sewer Impact Fee was previously \$1,795.00 (before the Wastewater Treatment Plant project). Without the increase to the \$5,250.00 fee, the total building fees are \$11,327.06, instead of \$14,782.06. Said \$1,795.00 fee for Perry's sewer lagoon system was only half the amount of Plain City's sewer impact fee for their sewer lagoon system.

**Note:** Unincorporated areas, such as South Willard, are not included in the comparison, since they do not provide the same comparable level of services, such as the lack of a Sanitary Sewer Collection System (septic tank systems are generally \$10,000 to \$12,000 or more).
