

RESOLUTION NO. 7-12-2012

A RESOLUTION APPROVING THE ADOPTION AND SUPPORT OF THE CLEVELAND COMMUNITY COVENANT TO HONOR AND CELEBRATE THE MILITARY MEN AND WOMEN OF CLEVELAND TOWN AND THEIR FAMILIES, AND ALL MILITARY MEN AND WOMEN, AND THEIR FAMILIES, WHO HAVE SERVED, OR ARE PRESENTLY SERVING IN THE MILITARY, AND THEREBY COURAGEOUSLY SUPPORTING AND DEFENDING OUR COUNTRY, EMERY COUNTY, AND CLEVELAND

WHEREAS, Cleveland Town recognizes that the strength of the community comes from each individual in it; and

WHEREAS, Cleveland Town recognizes the commitment and sacrifices that military men and women from Cleveland Town, and their families, have made and are continuing to make for our country, Cleveland Town, each and every day; and

WHEREAS, Cleveland Town supports the sentiment of Abraham Lincoln who “likes to see a man proud of the place he lives and likes to see a man live so that his place will be proud of him”; and

WHEREAS, the military men and women of the Armed Forces are constantly preparing to once again deploy overseas, to defend our country and the values upon which it has been built, and to advance the principles of freedom at home and abroad; and

WHEREAS, Cleveland Town acknowledges that “freedom is never free” and that the military men and women of the state of Utah, and their families, as well as all military men and women from Cleveland Town, and their families, who have served or are serving their country, are paying the price for freedom for all citizens of our country and Cleveland Town.
