ENTRY CONFIRMATIONS & JUDGING PROGRAMS

All trials are offering “For Exhibition Only” (FEO) in all classes.

An email confirmation will be sent at the time of processing if a **legible, valid** email address is provided on the entry form. Additional confirmations will be emailed to acknowledge move-ups and corrections/changes prior to closing. A final confirmation and judging program will be emailed after the trial closes. Printed confirmations and Judging Programs will be mailed via USPS to Exhibitors without email addresses after the trial closes. **PLEASE CHECK YOUR CONFIRMATION!** OWNERS/HANDLERS ARE RESPONSIBLE FOR REVIEWING ALL INFORMATION IN THE CONFIRMATION LETTER EACH TIME ONE IS SENT AND CONTACTING THE TRIAL SECRETARY IMMEDIATELY IN WRITING (EMAIL) IF A CORRECTION/CHANGE NEEDS TO BE MADE!

Any Exhibitor who does not receive a preliminary confirmation within 10 days of mailing a paper entry should contact the Trial Secretary to confirm receipt of paper entry. Any Exhibitor who does not receive the Judging Program within 7 days prior to the Trial should contact the Trial Secretary.

AWARDS & RIBBONS

A **qualifying score** is required for all awards. Placement ribbons will be awarded for 1st through 4th places in each height division of each class in each trial. Qualifying ribbons will be awarded to all dogs receiving a qualifying score. New title ribbons will be awarded to teams earning a new title. Clean Run ribbons will be available for Novice and Open runs ONLY. A commemorative MACH/PACH ribbon and MACH/PACH bar will be awarded to each dog earning a MACH or PACH title at these trials.

SPECIAL TRIPLE “Q” PRIZE: Every dog/handler team earning a Qualifying Score in a Standard class, JWW class and either a T2B or FAST (regular or preferred) in a single trial will receive a \$25 gift certificate. The prize must be claimed at the trial.

VOLUNTEERS

We appreciate our VOLUNTEERS!! There will be sign-up at the Chief Ring Steward Table where you can sign up to help. We will provide a \$2.00 voucher good for future HEAT entry fees or current trial concessions.

NOTICE TO EXHIBITORS

Declining of entries: The Hutchinson Kennel Club, Inc. may decline entries for cause and may refuse to receive or remove any dog on account of aggression, disease, deformity, injury, or illness which may affect the dog's physical or mental performance. No one shall have any claim or recourse against Hutchinson Kennel Club, Inc. or any official thereof.

Refund Policy:

- ❖ Entry fees will be refunded if an entry is pulled **before** the closing date and time.
- ❖ Refund checks must be cashed within 90 days or the check may be cancelled.
- ❖ NO refunds will be made for an entry pulled after the closing date except as stated in the Wait List policy found below.
- ❖ **Bitches in Season** are not permitted to compete in the Trial or be on the Trial site. HKC will refund full entries less \$10.00 per day for bitches unable to compete for this reason.
- ❖ **Dogs injured and/or unable to compete** will be refunded full entries less \$10.00 per day with verification from your veterinarian. The Trial Secretary must be informed of such claims in writing for refund at least ½ hour prior to the start time each day.
- ❖ **Entry fees will not be refunded** in the event that a dog is absent, disqualified, excused by Veterinarian or Judge, or barred from competition by action of the Trial Committee.
- ❖ **Entry fees will not be refunded** because of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy or any other cause beyond the control of the organizing committee or other acts beyond the control of the Trial Committee making it impossible to open or complete the Trial.
- ❖ **Returned checks** for any reason do not constitute a valid entry fee. The Trial Secretary will add a \$30.00 service fee for any returned checks.
- ❖ **No refund** for duplicate entries will be made. We will make every effort to find all duplicate entries, but if an entry has been processed, no refund will be made.
- ❖ **No entry fee will be refunded** in the event of errors, nor will cancellation of incorrect entries be allowed after the published closing date. Owners are responsible for errors on entry forms no matter who may have made said errors.

A Wait List will be created to fill openings created by withdrawn entries after the Trials' closing date/time. A maximum of 30 entries will be placed on the wait list. All entries, including wait list entries, must be received by the Trial Secretary prior to the closing date/time. Any entries withdrawn by the **PRE-TRIAL MOVE-UP DEADLINE** detailed on page 1 of this Premium will be replaced by a wait listed entry if any are available. If a withdrawn entry is replaced by a wait list entry, a full refund will be issued for the withdrawn entry. Any wait listed entry that does not move off the wait list into the trial will receive a full refund.

Exhibitors shall be governed by all rules, regulations, civil authorities, building and parking restrictions. Vehicles parked contrary to regulations will be subject to towing at the owner's expense.

The **safety of the dogs** is our primary concern. By entering this Trial, Exhibitors are acknowledging that they are familiar with the rules and regulations of this sport and that their dog(s) is familiar with and able to perform the obstacles safely.

All dogs must always be on leash except when in the ring or when in the designated agility warm-up area. It is expressly understood that Exhibitors alone are responsible for the behavior of

their dog(s) and/or child(ren). Any Exhibitor whose dog(s) and/or child(ren) create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the Trial site. In such a case, no refund of any fees will be made.

NO flash photography will be allowed while a dog is on the course.

Exhibitors are solely responsible for cleaning up after their dog(s). Any Exhibitor failing to do so may be excused without benefit of refund if the Trial Committee deems the Exhibitor to be in violation of this requirement. Cleaning supplies and disposal sites will be available.

Exhibitors are solely responsible for being at the Ring Gate and ready to go when it is their turn on the course.

AGREEMENT

I certify that I am the actual owner of the dog, or that I am the duly authorized agent of the actual owner whose name I have entered. In consideration of the acceptance of this entry, I (we) agree to abide by the rules and regulations of The American Kennel Club in effect at the time of this event, and any additional rules and regulations appearing in the premium list of this event and entry form and any decision made in accord with them. I (we) agree that the club holding this event has the right to refuse this entry for cause which the club shall deem sufficient. I (we) certify and represent that the dog entered is not a hazard to persons or other dogs. In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog.

Additionally, I (we) hereby assume the sole responsibility for and agree to indemnify, defend and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting therefrom, sustained by any person or persons, including myself (ourselves), or on account of damage to property, arising out of or in consequence of my (our) participation in this event, however such, injuries, death or property damage may be caused, and whether or not the same may have been caused or may be alleged to have been caused by the negligence of the aforementioned parties or any of their employees, agents, or any other person. I (WE) AGREE THAT ANY CAUSE OF ACTION, CONTROVERSY OR CLAIM ARISING OUT OF OR RELATED TO THE ENTRY, EXHIBITION OR ATTENDANCE AT THE EVENT BETWEEN THE AKC AND THE EVENT-GIVING CLUB (UNLESS OTHERWISE STATED IN THIS PREMIUM LIST) AND MYSELF (OURSELVES) OR AS TO THE CONSTRUCTION, INTERPRETATION AND EFFECT OF THIS AGREEMENT SHALL BE SETTLED BY ARBITRATION PURSUANT TO THE APPLICABLE RULES OF THE AMERICAN ARBITRATION ASSOCIATION. INSTRUCTIONS

Handlers whose dogs measure into the 8" through 20" regular jump height divisions may opt to enter in a higher or 24-choice **height division** for all **Regular** titling classes, but not in a division lower than their proper height division. Dogs who measure into the 24" regular jump height division may not enter 24-choice. Dogs entered in the **Preferred** classes **must** compete at the required jump height and **may not** compete in a jump height division **higher or lower** than their proper height division.

All dogs that have not been officially measured for an **Agility Jump Height Card** may still compete; however, they must be measured by a Judge of record, an Agility Field Representative, or a Volunteer Measuring Official, prior to running. If measured by the Judge of record, that measurement will be valid for this trial or *back-to-back trials* only. If a measurement is necessary, it is the exhibitor's responsibility to have their dog(s) measured prior to running.

Dogs listed in the **AKC Canine Partners ProgramSM** may be eligible to enter all-breed AKC agility trials at the club's option. These dogs should be listed as All American Dog and must include their AKC number on the entry form and check the AKC No. box.

Junior Handlers should enter their Junior Handler Number on the front of this form. Should you not have your Junior Handler number, it may be obtained from the American Kennel Club (919) 233-9767. If the Junior Handler is not the owner of the dog identified on the face of this form, what is the relationship of the Junior Handler to the Owner?
