DOGS ELIGIBLE TO ENTER

This trial is open to all dogs six (6) months of age or older that are registered with the American Kennel Club or that have an AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number, or are approved Foundation Stock Service (FSS) breeds.

The safety of our dog(s) is our primary concern. By entering this trial, exhibitors are acknowledging that they are familiar with the rules and regulations of this sport and that their dog(s) are familiar with and able to perform the exercises safely. Exhibitor(s) should follow their veterinarians' recommendations to assure their dog(s) are free of internal and external parasites, any communicable diseases and have appropriate vaccinations.

ENTRY INFORMATION

All entries must be submitted on official AKC entry forms, one dog per entry form. Photocopies of entry forms without the AKC Agreement and Rules are not acceptable. Unsigned, incomplete, or illegible entries are not acceptable. If you would like a confirmation that your entry was received before the trial has closed, please include your email address, or enclose a self-addressed stamped envelope. Please double-check your entries!!!! Entries cannot be changed once the trial has closed. NO refund for duplicate entries. IMPORTANT NOTICES TO EXHIBITORS

- All dogs must be <u>on leash at all times</u> except when in the ring. It is expressly
 understood that Exhibitors alone are responsible for the behavior of their dog(s)
 and/or child(ren). Any Exhibitor whose dog(s) and/or child(ren) create unnecessary
 disturbances or repeatedly engage in unsafe or disruptive behavior may, at the
 discretion of the Event committee, be asked to leave the Trial site. In such a case,
 NO REFUND of any fees will be made.
- Warmups must be done on lead. NO warmups can be done within 20 feet of the building.
- There will be NO OVERNIGHT CRATING in the HKC building. Handler/Owner must be present when dog is in the building.
- Due to limited crating space, NO x-pens or play pen crating will be allowed in the building. NO EXCEPTIONS. Please reduce crating space as much as possible, you may be asked to consolidate crating space if needed. Mats under crating requested.
- <u>Exhibitors are solely responsible</u> for being ready for judging when called to the ring.
- <u>Exhibitors are solely responsible</u> for cleaning up after their dog(s) and/or child(ren) at the show site, this includes the hotel/motel/RV park. Any Exhibitor failing to do so may be excused without benefit of refund if the Event Committee deems the Exhibitor to be in violation of this requirement. Cleaning supplies and disposal sites will be available when competing in this show.

NOTICE TO EXHIBITORS continued....

- All dogs in the ring must wear a properly fitted collar approved by the judge. NO dog
 may enter the ring, either for judging or for awards, with unacceptable equipment.
 NO special training collars, such as electronic collars or prong collars, will be
 permitted. Nothing may be hanging from the dog's collar per AKC Obedience
 Regulations, Chapter 2, Section 17.
- NO entry fee will be accepted which requires a signature for delivery.
- Exhibitors are responsible for errors on entry forms no matter who may have made such errors. NO entry will be refunded in the event of such errors, nor will cancellation of entries be allowed after the published closing date.
- Entry fees will not be refunded in the event the dog is absent, disqualified, excused by a veterinarian or judge, or barred from competition by action of the Show Committee.
- Entry fees will not be refunded if the trial(s) cannot be opened or completed by reason of extreme weather conditions, riots, civil disturbance, fire, an act of God, public emergency, an act of a public enemy or any other cause beyond the control of the Show Committee.
- Bitches in season are not allowed to participate. The Trial Secretary MUST BE notified <u>IN WRITING</u> of such a claim for refund <u>BEFORE THE TRIAL COMMENCES</u>.
 The Club will refund all but the AKC registration fee of the entry fee per day for bitches unable to compete for this reason.
- Photography WILL NOT be provided and NO flash photography is allowed in the building. Back drop will be available.

Additionally, I (we) hereby assume the sole responsibility for and agree to indemnify, defend and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting therefrom, sustained by any person or persons, including myself (ourselves), or on account of damage to property, arising out of or in consequence of my (our) participation in this event, however such, injuries, death or property damage may be caused. and whether or not the same may have been caused or may be alleged to have been caused by the negligence of the aforementioned parties or any of their employees, agents, or any other persons, I (WE) AGREE THAT ANY CAUSE OF ACTION, CONTROVERSY OR CLAIM ARISING OUT OF OR RELATED TO THE ENTRY, EXHIBITION OR ATTEN-DANCE AT THE EVENT BETWEEN THE AKC AND THE EVENT-GIVING CLUB (UNLESS OTHERWISE STATED IN ITS PREMIUM LIST) AND MYSELF (OURSELVES) OR AS TO THE CONSTRUCTION. HOWEVER, PRIOR TO ARBITRATION ALL APPLICA-BLE AKC BYLAWS, RULES, REGULATIONS AND PROCEDURES MUST FIRST BE FOLLOWED AS SET FORTH IN THE AKC CHARTER AND BYLAWS, RULES, REGULATIONS, PUBLISHED POLICIES AND GUIDELINES.

INSTRUCTIONS

- 1. (Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).
- 2. The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which, according to their owners' records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.
- 3. (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e, age division, color division, weight division.
- 4. A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his/her name. State on entry form whether transfer application has been mailed to the AKC. (For complete rules, refer to Chapter 11, Section 3.)
- 5. Mixed Breed dogs entering classes for Agility, Obedience, and Rally trials should mark Breed as "All-American Dog/Mixed Breed." Sire and Dam information shall remain blank for mixed breed entrants.
