Dear Ed:

As per our conversation on March 7, I have enclosed a copy of the letter the Kanosh Town Council would like to send to all off-highway vehicle users in Kanosh. I would also like to inform you that Kanosh Town Council repealed ATV ORDINANCE NUMBER 010991.

The Town Council adopted an OFF-HIGHWAY resolution similar to that of Fillmore City. I have attached a copy for your information. The only differences between Kanosh Resolution and Fillmore City Ordinance are:


- 1 Kanosh has imposed a 10 MPH speed limit instead of 15 as Fillmore
- 2 Kanosh requires an adult or guardian to be within 50 feet of the operator under 14 years of age.

It is our intent to do all we can to help solve the problem of ATV's and OFF-HIGHWAY vehicles running at random throughout the Town. I hope this approach the Town Council has taken will be of benefit to you, your Department and the Citizens of Kanosh.

In an effort to address numerous and continual complaints to this office about the unlawful use of A.T.V.'s (4-wheelers and motorcycles) in and around the town of Kanosh, we are attempting to contact all owners and users of these vehicles to help clarify laws, rules and regulations governing A.T.V. use.

Enclosed is a copy of current state laws addressing A.T.V. use. Also, state law allows counties, cities and towns by ordinance to designate select city or town streets or county roads open for A.T.V. travel for the purpose of an A.T.V. user to drive to public lands that permit A.T.V. travel and/or use.


Kanosh town council has chosen to permit, by ordinance, A.T.V. travel on all town streets, however, it should be noted that Main Street in Kanosh is a state highway, not a town street. You are allowed to cross state highways, but not travel on them. The use of town streets must be for the purpose of leaving or returning to town from designated A.T.V. use areas. The only designated A.T.V. use area near Kanosh is the access to the Paiute A.T.V. trail up Kanosh Canyon.

Millard County allows the use of the Kanosh Canyon road for A.T.V. use from Kanosh town limits east approximately one mile to the road that turns south across the Fish and Game property and to the beginning of the access to the Paiute A.T.V. trail. Any other A.T.V. travel in or around Kanosh is unlawful with the exception of those A.T.V.'s that qualify for and are registered as vehicles of animal husbandry under the A.T.V. laws. These vehicles are allowed to travel on any street, road or highway (except interstate highways) for the purpose of traveling from one parcel of property to another owned or operated by A.T.V. users or their employees.

Operators of A.T.V.'s used for agriculture must be 14 years old or older and are not required to wear a helmet. All other A.T.V. operators under the age of 18 are required to wear helmets. No person may operate an off highway vehicle unless they have a valid motor vehicle operator's license or an appropriate safety certificate issued by Parks and Recreation. Operators age 8 to and including age 13 are required to be accompanied by an adult while traveling on Kanosh town streets and the Kanosh Canyon county road. Violation of any A.T.V. law is subject to a \$50.00 fine.

I strongly encourage you to study the enclosed copy of A.T.V. laws and discuss the contents of this letter with family members, employees or others who may be operating A.T.V.-type vehicles belonging to you.

If you have any difficulty understanding the A.T.V. laws or other issues discussed in this letter, please feel free to contact me or any other local law enforcement officer. With your help and cooperation, local A.T.V. use can happen and happen safely. Strict enforcement of the A.T.V. laws will be forthcoming from this office in the future.
