13-20-3 DOGS

POLICY

IT SHALL BE THE POLICY OF KANOSH TOWN TO SET TRAPS TO CATCH DOGS RUNNING AT LARGE. IT WILL ALSO BE THE POLICY OF KANOSH TOWN TO NOT RETAIN THE DOGS IN A TRAP FOR A PERIOD OF MORE THAN 12 HOURS. IF A DOG MUST BE KEPT LONGER THAN 12 HOURS IT WILL BE TRANSPORTED TO THE ANIMAL SHELTER IN DELTA. ANYTIME A DOG IS TRANSPORTED TO DELTA THERE WILL BE A \$50.00 TRANSPORTATION FEE ASSESSED TO THE DOG OWNER (PLUS LICENSE FEE IF APPLICABLE). A DOG TRAPPED THE 1ST TIME WILL BE RETURNED TO THE OWNER (IF IT CAN BE DETERMINED WHO THE OWNER IS) AND A \$20.00 FEE ASSESSED. A DOG TRAPPED A 2ND OR SUBSEQUENT TIME (S) WILL BE AUTOMATICALLY TRANSPORTED TO THE DELTA ANIMAL SHELTER. A FEE OF \$50.00 PLUS LICENSE FEE IF APPLICABLE PLUS HOUSING COST OF THE DOG MUST BE PAID BEFORE THE DOG WILL BE RELEASED.

PROCEDURE

WHEN A DOG IS TRAPPED IF IT HAS A TAG OR CAN BE IDENTIFIED THE ANIMAL WILL BE RETURNED TO THE OWNER. THERE WILL BE A 1ST TIME APPREHENSION FEE OF \$20.00 PLUS A LICENSE FEE IF APPLICABLE. IF THE DOG IS APPREHENDED A 2ND OR SUBSEQUENT TIME THE DOG WILL BE TRANSPORTED TO THE DELTA ANIMAL SHELTER. BEFORE THE ANIMAL WILL BE RELEASED A \$50.00 FEE PLUS LICENSE FEE IF REQUIRED MUST BE PAID TO THE TOWN TREASURER OR HER REPRESENTATIVE. SHE IN TURN WILL ISSUE A CERTIFICATE THAT CAN BE PRESENTED TO THE POUNDMASTER IN DELTA SHOWING THE APPLICABLE FEES HAVE BEEN PAID IN KANOSH. THE PARTY REQUESTING THE DOG MUST ALSO PAY THE NECESSARY HOUSING FEES AND OTHER FEES CHARGED BY THE DELTA ANIMAL SHELTER BEFORE THE ANIMAL WILL BE RELEASED.

SHOULD THE DOG OWNER BECOME AWARE THAT THE DOG HAS BEEN TRAPPED A 2ND TIME AND MAKES CONTACT WITH KANOSH TOWN BEFORE THE ANIMAL IS TRANSPORTED TO DELTA THE ANIMAL MAY BE RELEASED TO THE OWNER PROVIDED THE \$50.00 FEE FOR A 2ND TRAPPING IS PAID.

If a dog owner is issued a citation, fee of citation is \$50.00.

If that pet has no license, there will be an additional fine of \$20.00 for no tag, plus the licensing fee, complete with proof of rabies shot and proof of being spayed or neutered.

Fees payable within 30 days, if individual pays incurred fines or fees within 10 days of the issuance of citation at the Kanosh Town hall, \$20.00 of the initial \$50.00 fee will be suspended, creating a fee of \$30.00, plus licensing fees. If the pet owner exceeds the 10 day grace period he/she will be required to pay the \$50.00, plus licensing fees, plus any court costs incurred, at Millard County Court.

Spayed or neutered dogs:	\$10.00
Males:	\$20.00

13-20-3-02. LICENSE AND REGISTRATION REQUIRED.

1. It is unlawful for any person to keep, harbor or maintain any dog three (3) or more months old unless such dog has been registered and licensed in the manner herein provided.

2. Application for registration and licensing shall be made to the poundmaster or such other person as the governing body may authorize to receive such applications.

3. A dog license shall be issued by the poundmaster or such other person as the governing body may authorize.

4. No dog license shall be issued by the municipality until the fee required herein is paid. Until otherwise changed by resolution of the governing body, the following fee shall be charged:

| d. Each unneutered male | 10.00 20.00 |

5. The fee due and payable pursuant to this section shall be due August 1st and shall be delinquent after August 31st of each year. A penalty of fifty (50) percent shall be added to delinquent payments.

6. The owner of any newly acquired dog of licensing age or of any dog which attains licensing age after August 31st of any year shall make an application for registration and license within ten (10) days after such acquisition or dogs attain the above stated age; provided that the license fee shall be pro-rated of the above required for new applications received after August 31st of any year.

7. Anyone owning, keeping, harboring, or maintaining five (5) or more dogs over the age of three (3) months shall be considered operating a kennel and shall be required to pay an annual kennel license fee of \$25.00 per year, plus dog license fees.

8. The owner shall state at the time application is made for such license, his name and address and the sex, breed, and color of each dog owned or kept by him. The license fee shall cover the period August 1st thru July 31st. Any fee paid during the month of August or thereafter, will be pro-rated, on a monthly basis, as to expire on the following 31st of July.
