Dear Livestock Owner,

Paragraph 2-26 of the Revised Ordinances of the Town of Kanosh, Utah 1972 passed and adopted the 9th day of December 1971 is quoted as follows:

"It shall be unlawful for the owner of any animal that shall die or be killed within the limits of this town to fail to remove or bury the carcass of such animal within 10 hours after its death, provided that no horse, cow, ox, or other animal shall be buried with the closely-inhabited portions of the town."


Based on the above ordinance the town officials agreed to maintain a flesh pit at the old town dump site to facilitate the disposal of dead animals. This is a convenience provided by the town for the livestock owners and is not a requirement.

The Federal and State laws established for the preservation of the public health and the elimination, prevention and restriction of diseases apply in the disposal of dead animals. We are doing our best to help you to comply with these laws, with the least impact, but you must follow the guidelines. You are hereby notified that you must dispose of your dead animals by burial on your own property as provided by the town. This does not mean on the road to the dump or around close by the pit or any place else. They must be placed IN the pit or buried as specified. Animals left out of the pit and can be identified as being the property of an individual, partnership, company, or corporation, will be cause for that individual and firm to be charged with a violation of the applicable ordinances and laws of the Town of Kanosh and the State of Utah and they will be prosecuted accordingly.

We have been approached again by the State Health department on this matter and we must cover dead animals as they are placed in the pit. We will do the cover up as required, but you must assist us on this matter and place animals in the pit, if you are going to preserve this convenience.

Your co-operation in this matter is essential if the flesh pit is to remain as an option for the disposal of dead animals.
