

Village of Downs Board of Trustees Regular Meeting February 10, 2022, 7 pm @ Village Hall & via ZOOM

- 1. Mayor Mike James called the February 10, 2022, Village of Downs Regular Board or Trustees meeting to Order at 7:01pm.
- 2. Roll Call was taken. Trustees present were Maureen Roach, Peggy Keylin, and Brian Warfel. Anna Milliken and Sarah Gassaway were absent. Toby Twyford was present via zoom. Also present in person were Village Clerk Julie James and Village Treasurer Julie Bakewell. Village Attorney Dawn Wall was present via zoom. Mayor James declared a quorum to do business.
- 3. The Pledge of Allegiance was recited.
- 4. A motion to Approve Agenda and Order was made by Keylin and seconded by Roach. Approved 4-0
- 5. Zoning Board of Appeals Chr. Linda Bowman
 - Chr. Linda Bowman reported the zoning board recommends the approval of 01-22-ZMA SU-V.
 - A motion to approve Ordinance 2022-01 Approving the Zoning of Parcels #29-04-178-004 and #29-04-178-014 Owned by the Downs United Methodist Church from P, Public to C-1, Central Commercial District with Special Use and Variances was made by Warfel and seconded by Twyford. Approved 4-0

Discussion -

- Keylin asked what the impact of commercial (kinds of businesses that will be in there) in a residential neighborhood? Rick Hayes DUMC trustee, the "impact" will be money towards the village. The new buyers are going to maintain the history of the church. He doesn't see that these businesses will be a problem. But there is no set plan.
- The idea of a daycare is being taken off the table.
- Keylin had a concern for adequate parking. James noted that OTTR does not have parking and we have not restricted them and further stated the Village needs business and we have to be sure this is not grandfathered.
- 6. Guests Phil Knight Of Utilities Service Co., Inc.
 - The company maintains water utility assets (wastewater treatment plant, meters, water towers)
 - They inspected our tower last fall.
 - They have submitted a renovation/maintenance proposal for us to consider.
 - Phil explained the scope of work that would be done over 17 years.
 - Wall asked if we could get a letter of credit in case they were not in business. He said that would not be a problem.
 - Twyford asked if there is an "out" of the contract? Depending on what year of the contract we want out, we may be responsible for payments made before years 7 and 8.
 - Buzicky says what Phil has presented is great/thorough and the cost is very appropriate.
 - James said he has had 3 companies come and give us a bid. This company seems the best for our needs.
 - James said he is hoping that McLean Co will approve the rural community ARPA funding requested by the Mayors Association to aide in our infrastructure needs. This project was submitted by Mayor James.

7. Events Report

- The events committee is having discussions about a new digital sign for advertising.
- The other sign was destroyed in the windstorm.
- The committee is looking for a bigger investment and would like to get a LED digital sign at the entrance of town at Seminary St. coming in from the interstate.
- The new sign would have multiple uses, boil order announcements, community events, village events and other announcements.
- Roach, Keylin and Warfel were all in favor.
- Twyford says we have 4 entrances into village.
- This year's Easter breakfast is going to be at The Union and will use a reservation system just like the haunted house and Cookies with Santa used.
- 8. Engineer & Development Report by Mike Buzicky
 - 1. Down Water Plant Improvements
 - BNWRD will accept our backwashed water from the new plant.
 - No comments have come back from the EPA loan packet.
 - James said we have several new projects and subdivisions on the horizon. Will the new water plant be able to handle this growth? Buzicky said the new plant can handle double of what we can do today.
 - 2. Downtown Streetscape and Parking Lots design
 - McLean County is making upgrades to Seminary St. We gave them some of our draft plans that were designed by MSA.
 - 3. Downs Crossing Watermain Extension no discussion
 - 4. S. Lincoln and Colleen Lane Water and Sewer Extension
 - We have received the materials and the bill is on the BTP for tonight.
 - 5. S. Lincoln, Colleen Lane, and Hillard Court Road Projects no discussion
 - 6. Beecher Trails Second Addition (Phase 3)
 - James said he is asking for approval for engineering plans. They will be doing the looping of the watermain which should help with quality and pressure.
 - 7. Huff Road Subdivision
 - Because of the economics of selling lots, they are wanting to put 5 lots on the corner. We asked them to consider 4 lots back in 2017 when they came to the board.
 - Roach noted it will be a lot of traffic on the corner.
 - We would have to amend our agreement.
 - Board decided they would like to have a public hearing.
 - 8. Williamson Subdivision
 - A petition has been submitted to the zoning board requesting R3 and C2 with variances. ZBA public hearing is being worked on and scheduled in Feb/March.
 - 9. Other Engineering or Development Updates
 - Wall says we don't need a franchising agreement needed for Metronet. Metronet is putting in fiber but would like an indemnification clause in our agreement.
- 9. Mayoral Report nothing else to report

 - Roach reported they are working on getting heat and electricity in the new police building.
 - Bills for flooring finish and evidence room are on the BTP.
 - Dingler reported it was a light month in policing.
 - Dingler submitted a hazard mitigation project to the county.
 - The recent snowstorm didn't cause too many issues.

4. Streets Reports

- Warfel gave a big thanks to Mayor James and everyone who plowed.
- The F650 was delivered to Koenig in Peoria and is getting outfitted.
- 5. Parks, Community Center and Food Pantry Report
 - The committee is working on next year's budget.
 - Hunter Zachow is exploring the idea of building benches for the ball courts in Dooley Park as a potential Eagle Scout project.
 - Parks is submitting an application for the 2022 State Farm \$25,000 Neighborhood Assist Grant. We are focusing on building community through inclusivity by providing play and exercise spaces for teens, adults, and those with special needs.
 - A group of friends plan to plant a tree in Dooley Park in Bob Clark's memory.
 - Peggy (Keylin) surveyed downed trees and debris in Kickapoo Creek and is asking the Boward Brothers for an estimate on removing it.
 - We had 2 of 3 furnaces in the pavilion serviced.
 - We are having electric work done on a faulty socket in the pavilion.
 - The committee is working on an Earth Day Celebration in late April.
 - The Food Pantry is in the process of patching and painting the interior walls and ceiling.
 - They plan to distribute 38 boxes this week with one new client.
- 6. Finance and Services Report
 - Bakewell went over the BTP.
 - Unique bills
 - The AREA bill was increased in Jan. and reflects all our current customers.
 - There are auction items in general and events.
 - The Bryant Masonry bill is for material for the police building.
 - Plumb Crazy is being deleted from BTP.
 - A Tammy Kirby bill is being added.
 - The first truck payment for the F650 is on the BTP.
 - Embark Tree Removal (Parks)
 - Nicor bills are 2-3 times of what they were last year
 - Bakewell spoke with Nexamp to see when we can get the other 5 accounts up and running. She also has a question about their kilowatts meeting our needs.
 - Bakewell is working on the draft budget.
 - She has been unable to get into the IL Comptroller's system.
 - Bakewell would like to know how we are paying sick leave, for covid/non-covid, part time employees for covid/non-covid. Wall says we need to be consistent.
 - Health Insurance Plan -Van Gundy said we needed 3 full-time employees to start the plan.
