From the Desk of the Mayor

It has been another busy month in the Village.

- 1) The new Village LED sign is operational and looks fantastic. Thank you, Bryant Masonry and Heartland Electric. We will need some time to determine how the sign works and formulate a program for advertising.
- 2) The Haunted House is underway and breaking records for attendance. It is great to see attendance up for one of our best haunted houses ever.
- 3) At the Board of Trustee meeting, we approved several membership renewals for water and Chamber of Commerce.
- 4) We made some changes to the policy handbook to clarify vacation accumulation and eligibility.
- 5) We approved the final plat for the Quality Oil Subdivision.
- 6) Finally, we continued the Board meeting to Oct 24, 2023, 7 pm @ the Village Hall for approving the annual audit, treasurers, and TIF report.
- 7) Linda Bowman has resigned as the Chair of the Village of Downs Zoning Board of Appeals. See recognition and announcement of opening later in the newsletter.

Water plant rehabilitation:

- 1) The water plant rehab is underway. Starting with removing the current roof where the new building extension will attach to the existing building.
- 2) They hope to have the extension enclosed by winter so internal work can be completed over the winter.
- 3) The new well will be installed this fall but the bore for the feed watermain from the well will be installed before Haunted House ends.
- 4) The sewer discharge manhole and lines will be installed. This will cause Franklin and Water Street to be closed for a period in October.
- 5) We estimate the plant will come online around Christmas of 2024 and fully operational in February 2025.

Water rate increases:

- 1) Water rates will increase once the plant is operational, and this amount will be an estimated \$16. However, you will no longer NEED RO, bottled water, or water softeners.
- 2) Debt Service amount is currently slated to be \$34.07 for a total increase of \$50.06 per month. Until we know the full impact of 1% infrastructure tax increase from Roanoke being operational in 2024, we will not know how much we can reduce the \$34.07 debt service.
- 3) We hope and expect the rate increase and debt service increase will be offset by the reduced expenditure of no longer needing personal systems and 1% sales tax.
- 4) Please note that using a water softener after the new plant goes live could be harmful to copper pipes and is not recommended. Softening water to 90%+ will make your water "thirsty" for minerals and will look to copper pipes for those minerals. We expect our plant to be tailored to soften the water 70-80%.
- 5) If you have any further questions or concerns about the water, please reach out.

UPDATED: We continue to work on the following major items. Dollar amounts provided are estimates. Actual numbers will not be known until bidding and final 1% sales tax revenue is received (updates are bold and in italics):

- 1) Plans for water main extension to Downs Crossing via Rt 150, New tower, and looping dead ends:
 - a. Project will provide clean (safe arsenic levels) drinking water to Downs Crossing and make it business friendly and ready for new businesses to build. Project will increase water pressure for Beecher Trails, Village, and Indian Hills by looping the system. Project will provide increased daily water supply to Downs and increase our total stored water capacity to 250k gal.
 - b. New Phase I is presently estimated at \$2,112,461.
 - c. Phase II is presently estimated at \$2,000,000.
 - d. Pushed project out due to delay in starting water plant rehabilitation. New estimated completion Timeline: Phase I = 4/2025; Phase II = 4/2026
 - e. Received a \$1.25 mil grant from the IEPA that will mostly be applied to Phase I. Excellent news.
- 2) Downtown Streetscape and Parking
 - a. Starting the paperwork and process to get this project rolling with our \$2.128 mil

federal grant. With the bids received for our water plant we are not sure how far this money will take us.

- b. Grant is through HUD, so we have a lot more requirements.
- c. Expect to hold public hearing on the new design in Dec 2023 & then will hold another in the Spring of 2024.
- 3) Extend Water and Sewer to Freedom Oil Hoerr Construction had the lowest bid to do the Rt 150 water main bore at Downs Crossing. They will perform the work in 2024 but will order the material now to preserve lower price on material.

REMINDER: The billing due date is the **15th of the month**. Payments received after the 15th are subject to the late fees.

The Village is using an **ACH** (automatic withdrawal) program. This program has NO FEE to you! If you sign up for this program, you will continue to receive your monthly bill. On the 15th of the month, the Village will withdraw the entire amount due from the checking or savings account you provided on the authorization form. Authorization forms are on the website and will need to be submitted to the Billing Office by the 1st of the month you wish your first payment withdrawal to be made.

Reminder: if an ACH comes back as NSF it is treated like a check and cash or money order is needed to cover the NSF ACH. A 2nd NSF will result in no longer being eligible for ACH and all payments will need to be in cash or a money order. Please put your service number on your payment.

All Building Permits

All Building and Demolition Permit Applications must be processed, approved, and issued a permit number BEFORE WORK CAN BEGIN. This includes small projects, renovations, and new builds which could take up to 2 weeks to process. Please leave enough time before working on your project.

Water Sewer report for September 2023.

The average iron concentration for the finished water was .68 ppm. Monthly bacteriological testing on the raw, finished and distribution samples were all satisfactory, fluoride concentration was .65. The volume of water pumped for the month was 2.900 averaging 96,666 gallons a day. The sewer lift station pumped 2.067 million gallons for the month averaging 68,900 gallons per day.

Monthly Brush Pickup Continues

Each year, depending on our Streets Department ability, the Streets Trustee will put in the flyer if we are able to continue with this service. Debris pickup will continue, based on the Streets Trustee's direction, the first MONDAY of each month. Pickup will run from April through November (weather permitting). If the designated Monday pickup is not favorable, we will pick up on the next nice day following that Monday. The following are the rules we will follow with no exceptions.

- Items to be picked up must be burnable and free from all nails, screws, and metal (ex: Leaves, sticks, brush, branches, etc.)
- All items must be within the Village right away on curb, driveway or as close to the road as
 possible without creating a hazard in the road. (Note: Since we use a backhoe, in most
 cases, to do this work, we DO NOT want to tear up or rut yards or ditches. If we can't
 reach the debris from the road or a driveway, we WILL NOT pick it up.

Please note that there is NO BURNING in the ditches or on the road. Doing this causes clogging and backup in the ditches and culverts. It can also damage the road surface causing us to spend what little tax dollars we must, to fix these issues.

FY2024 (May 2023 – April 2024) Village of Downs Event Plan Current Plan—Subject to Change

The following describes each planned event at a high level. Further details and changes will occur during final planning by the committee or sub-committee in charge of the event. Budgets have been estimated based on last year's expenditures and revenue. Some events have been eliminated due to lack of participation or they were merged with something else.

- 1. **Dooley Park Cruise-In** This event will be held Saturday June 3^{rd} in Dooley Park from 3-7 pm. There will be no rainout date.
- 2. **Village Cleanup Day** This event will be held on the first Saturday in June each year. We hope to have containers for garbage, recycle, electronics, batteries, tires (extra fee). Home pick up can be arranged for a donation.
- 3. **4**th of July This event will be the first of two large events for the Village. This year will be a one-day event.
- 4. *Freedom Run* The Freedom Run will be held July 15th and is a 5K Run, 1 Mile Walk & Kids Fun Run held at Tri-Valley Middle School & High School.


