# From the Desk of the Mayor October 2017

This month's Board meeting again continued our talk regarding development; both residential and business.

We had two ZBA meetings already this month. These ZBA meetings are stepping stones for the next development proposals within Downs. At Downs Crossing, Corn Belt Energy received ZBA and Board approval for their long overdue storm water detention plan for Corn Belt Energy Park. This ~2-acre pond will be the first of its kind for our area and will be a dedicated park & pond for the Village as required by the 1999 annexation agreement. Corn Belt Energy will be letting for bids and they hope to break ground this fall or next spring. This project has to be completed to take that next step for development at Downs Crossing. The water extension, plant improvements and water supply will need to be our next focus for this development. This project will not happen overnight and we will need input from you, but we have to start now.

The second ZBA meeting was for 2 rezoning requests and village zoning code changes. The first request approved by the ZBA was for the new business/residential development on Main St, which was a change from C-2 to C-1. The Board also approved the \$70,000 TIF project funding for this project on an estimated ¾ million-dollar project. The vacant house and trailer will be torn down/removed and a new multi-use building will take its place. Current plans are for 2 businesses on the bottom and 3 apartments on the top with off-street parking. We are excited to see a new development like this in our downtown.

The other rezoning request approved was to change the land south of Beecher Trails from Ag to R-2. The land is being positioned for an additional subdivision of approximately 100 lots with 70' frontage and a ~5-acre park. The target house price is \$220-\$250k and the lot size is what makes this possible. A similar subdivision is being built in Mahomet, IL. The biggest issue raised thus far, is the entrance and exit into the subdivision. The developers are proposing putting in a traffic signal on Rt. 150 and Huff Rd to correct the traffic issues at this intersection, but more discussion is needed to alleviate these concerns.

# Streets Trustee Position Open

## PLEASE CONSIDER SERVICE TO YOUR VILLAGE

The Mayor will be accepting letters for consideration for this position. Your term of office will be the remaining months until April 30, 2019. If you decide to continue, you will need to run for a two-year term in the 2019 April election. You will be paid \$125 per regular or special board meeting.

You are eligible to be a Trustee if you are a registered voter and a resident of Downs for at least one year prior to the date of the election. A person is not eligible to take the oath of office for a municipal office if that person is, at the time required for taking the oath of office, in arrears in the payment of a tax or other indebtedness due to the municipality or has been convicted in any court located in the United States of any infamous crime, bribery, perjury, or other felony [65 ILCS 5/3.1-10-5(a)(b)] s.

# CLARIFICATION AND REMINDER - NOVEMBER 2017 WILL BE THE LAST MONTH FOR PICKUP

The Village provides the service of once a month pick-up of material that can be burned. However, we have been getting swing sets, household items and other stuff with nails, screws, bolts, etc. Some stuff just dumped at our storage (see above notice) and others left on side of road.

The Village will no longer pick up items that have sharp objects, hazardous material, or metal in the mix with burnable items or trimmings. You can remove all nails, screws, bolts, metal, etc. and we will take. Otherwise, it will be left. No exceptions.

Also, the Village doesn't take stumps, logs, branches, etc. that have been cut by a hired or professional company and left. If you hire someone to cut down a tree or do a trim service, they must haul away (not to our village storage field) what they remove. Again, no exceptions.

Additionally, we have contracted with AREA to do once a month bulk pickup as a part of their contract. On the schedule—that was mailed to each homeowner, it contains instructions for how to use that service. Here is the verbiage on that mailing just in case: Bulky items will be picked up at no cost (sofas, desks, old mattresses, etc.) the first pickup of each month. If unable to wait for the regularly scheduled pickup of bulky items, please call to schedule a pickup on a different day and pay \$35 per item.

# October 2017 Parks Report

This month has been full of new ideas from younger members of the Downs community. Two students from Tri-Valley High School, Taylor Grundler and Jacob Jones, presented ideas for their Innovation Project class. Both students enjoy Kickapoo Park and want to help with its restoration. They had many great ideas. The committee thought a stepping stone bridge to the small island, benches in strategic places and providing a first aid kit in the park could be implemented within the Prairie Floodplains Restoration Project. Both students were interested in getting involved in the ground clearing and planting steps of restoration. John Symanski identified two possible sites for the Gaga Ball pit. Boy Scout Troop 953 is looking for a service project in Dooley Park. A wood duck house built by the Downs Topnotchers 4-H Club was installed in Kickapoo Park this past weekend. Many thanks to the Alt family for spearheading this project. Boy Scout Nick Atteberry is resubmitting a proposal for a horseshoe pit for Dooley Park. Justin Bean, a volunteer for the Food Pantry and a member of TVHS Horticulture Club, will contact the committee with a landscaping project idea. Boy Scout Troop 953 had made an inquiry about possible service projects in Dooley Park.


The committee saw completion of several projects this month. Bolts were tightened on the playground equipment, fence poles were given a first coat of paint, the Girl Scouts installed trashcans in Kickapoo Park, and the downed mulberry tree was removed. We have a new stainless-steel coffee maker in the pavilion. A shelving unit and a loading cart donated and refurbished by Bob Milton Trucking Company, Bill Clark and Danny Thomas has been installed in the Food Pantry.

Movement has been made on several ongoing projects. We have requested a third estimate on the pavilion roof project. Jeff Schenkel is looking into lighting problems and solutions near the basketball courts. We will repair the solar flag light fixture in Dooley Park. We are researching 3 basin sinks for installation in the pavilion. The committee is also researching grants and monies that may be available for various projects connected to our parks.

The Food Pantry hopes to distribute 35 boxes this month. To help celebrate the upcoming Halloween holiday, the boxes include candy for Trick or Treaters. They are expecting donations in the next few months from several different sources. They're already looking ahead and planning for Thanksgiving and Christmas. Thanks to all volunteers! 

> **REMINDER**: The billing due date is the 15<sup>th</sup> of the month. Payments received after the 15th are subject to the late fees. In September there were 3 shut offs due to non-payment.



If using on-line banking to make your payments please be aware that the Village does not receive the funds via a transfer. Physical checks have to be sent to the Village, so time for the checks to arrive through the mail needs to be allowed for. Usually bill pay through your bank is at no fee, but you need to check with your bank.

Another option for payment is epay. There is a link on the Village of Downs website (villageofdowns.org). Please note that there is a fee for this service. When using this service the payment is not settled immediately and can take a couple days, so please allow for this in making your payment.

Water Emergencies such as no water or water leaking need to be reported to Kevin Whitehouse at 378-2137 or 319-1010. The water trustee is Toby Twyford and he can be reached at 309-830-3448.



All properties with access to the sewer main will be required to connect on or before June 1, 2019 or 180 days when any of those properties change ownership. Additionally, any new building constructed on property within 200 feet of the sewer line will also be required to connect.

Those that have not paid the BNWRD fee need to be aware that the fee is currently \$2,975. Monthly bills now include the BNWRD Property Tax. This is not an optional fee, and the Village is responsible for paying this to BNWRD.



Garbage contact is Area Disposal and they can be reached at 800-935-5652, or contact Maureen Roach, Public Safety Trustee, at 830-3606.

REMINDER: Yard waste, construction materials and electronics will not be picked up by the garbage company. Items containing Freon need to be drained before being placed out for garbage pickup. Please have garbage to the curb by 6am on pick up day.



Curbside recycling is the 2<sup>nd</sup> and 4<sup>th</sup> Friday of the month, unless there is a holiday during the week then pickup will be Saturday. Water and sewer report for September 2017



The average iron concentration for the month in the finished water was .36 PPM. Monthly bacteriological testing on the raw, finished and distribution samples were all satisfactory, fluoride concentration was .696. Lead and copper sampling results came in under the MCL (maximum contaminate level) allowing us to continue reduced monitoring of every three years. Water pumpage for the month was 2.385 million gallons, averaging 79,500 gallons a day. The sewer lift station pumpage for the month was 1.335 million gallons, averaging 44,500 gallons per day. The hydrant at W. Main and Gadwall broke in the open position while it was being used to fight a fire on N. Pintail, repairs have been made and the hydrant is back in service. The two hydrants at Beecher Trails are now raised to the proper level.






