- 1. Mayor Mike James called the February 9, 2017 special meeting to order at 7:01 pm.
- 2. Roll Call was taken with Trustees Roach, Goveia, Keylin and Twyford. Mayor James teleconferenced in Trustees Gassaway at 7:01 pm. and Lush at 7:02 pm. Also present were Clerk James and Attorney Wall. There was a quorum to do business.
- 3. The Pledge of Allegiance was taken.

# 1. REDLG

- Steve Hancock from Corn Belt was present to answer questions.
- Steve reported that the village was notified that if we didn't use the REDLG they would be swept. We want to use them for water.
- He discussed with Gildner that we had some extra funds. Gildner is going to give us a "like bid" to put in the extra feet of pipe.
- The current resolution provided by Wall will allow other improvements. Hancock indicated that there is some other development coming up.
- The North loop is filled, chlorinated and on Monday will be tested. Since, Kevin Whitehouse is gone, Les Fitzwater or someone from Heyworth can come for the testing.
