

VILLAGE OF DOWNS BOARD OF TRUSTEES SPECIAL MEETING MINUTES SEPTEMBER 26, 2019 7 PM @ VILLAGE HALL

- 1. Mayor Mike James called the Village of Downs special board meeting to order at 7:02pm on September 26, 2019.
- 2. Roll Call was taken. Trustees Maureen Roach, Mary Goveia, Peggy Keylin, Toby Twyford and Sarah Gassaway were all present. Erik Bryant was absent. A quorum was declared by Mayor James. Also, in attendance were Clerk Julie James, Treasurer Julie Bakewell and Village Attorney Dawn Wall.
- 3. The Pledge of Allegiance was taken.
- 4. A motion to Approve Agenda and Order was made by Keylin and seconded by Roach. Approved 5-0

5. Discussion

- Water Plant Study Options and Financials
 Mike from MSA summarized all three options, with more emphasis on Option A and
 Option C.
 - Option A Larger filter, adding tannin removal, adding softening (with building addition)
 - Option C Larger filter, adding an R/O process. This process wastes water and requires a higher licensed operator.
 - Options A and C would probably double the amount the average user pays on their water bill.
 - Option B would increase water bills by about \$13 more amount.
 - Trustees may need to re-evaluate how water is billed. Consumption tiers were a suggestion.
 - Gassaway noted that Option B is the minimum we should do. If we look for growth in the village Option A needs to be the option.
 - Roach asked if MSA would have a public forum so residents can ask questions.
 MSA was open to that idea, but offered up the online survey as another option.
 The survey worked well for the streetscape survey.
 - The Mayor took a straw poll and trustees felt like Option A was the most appropriate option. That gave MSA direction of what to pursue for us. They will help us find funding based on the dollar amount of Option A.

2. Other

- James said the DECO grant for \$25,000 was approved. Mayor will engage Farnsworth since they did the preliminary paperwork. James is going to ask for a cost estimate prior to work starting.
- An employee handbook that addresses cannabis usage will need to be implemented.
- James is looking to hire Steven Miller. Miller would work evenings and weekends.
- James also said he is looking at hiring Lexington's water operator. Their operator will help Les establish processes and sign off of our paperwork. His salary would be \$500/month
