- 1. Call to Order at 6:12 pm
- 2. Roll Call
  - a. Julie James, Mike James, Ken Kasprzak, Steve Miller, Cyndi Miller were present
  - b. Jill Kasprzak, Fred Myers, and Linda Roberts were absent
  - c. A quorum was declared to do business
- 3. Pledge of Allegiance
- 4. Discussion
  - a. FY2021 Budget Review
    - 1. Mike covered the budget documents from the board meeting
    - 2. Received donations and sponsorships for 5k, 4<sup>th</sup> and movies in the park \$1200 total so far
  - b. Garage Sale Days (June 5-7)
    - 1. If we are at Phase 3 by June Mike will not cancel this
  - c. Clean-up Day (June 13)
    - 1. We will have this event regardless of where we are in the Governor's plan regardless of the phase.
    - 2. We are not going to take electronics as people can take them into Normal on their own and the Village can't.
    - 3. We are still taking tires for the \$5 each
  - d. Freedom Run (June 27)
    - 1. Planning contingency plans for the race but are still planning on having it.
    - 2. Feather flags need to be ordered: 8 flags: start, finish, registration, 1-mile, 2-mile, 3-mile, 2-slow down or caution flags
    - 3. We talked about ordering 10 flags, so Mike asked what the Haunted House needed.
    - 4. Need to order them ASAP and hope they get to use before the Freedom Run
    - 5. We will want to try and order from featherflagnation.com because it is cheaper than buildasign.com. Feather Flag Nation is running a good special on their standard flags. It will cost about \$91 /flag
  - e. 4<sup>th</sup> of July (July 4)
    - 1. Talked about if we realistically can still have 4<sup>th</sup> of July
    - 2. Mike covered that he thinks we will be in Phase 3 at the end of May and that he will more than likely allow the HOI Reopening Plan
    - 3. We have already prepaid for our fireworks. Preliminary planning would be just to have the fireworks and nothing else. We will need to plan out how to distance and crowd control.
  - f. Movies in the Park (Aug 15?)
    - 1. Received \$100 sponsorship from St. Mary's Catholic
