From the Desk of the Interim Mayor

The month of May brought many administrative changes to the Village Board. Mayor Mike James and Clerk Julie James completed their elected terms of service to the Village of Downs on May 8th. Mike served as mayor for 12 years and an additional four years as streets trustee. Julie served 12 years as the clerk. I want to thank them for their contributions and successes in making Downs a better place to live.

Re-elected trustees for four years are Sarah Gassaway and Maureen Roach and newly elected trustee Diana Reynolds, who were sworn in by McLean County Clerk Kathy Michael on May 6. Also, new to the role of clerk is Rachel Eagles, who will be serving a two-year appointment. In addition, I was appointed by the Board as the Interim Village President until a mayor is appointed. Mike James was approved to serve as consultant on an as-needed basis to help provide his knowledge and experience on several complex projects in the works which will benefit the Village and ensure a smooth transition.

From the Desk of the Interim Mayor

MSA has submitted the operating permit to IEPA for the water treatment plant improvements, and they are currently reviewing the permit. The water plant construction phase is completed and ready to go operational, pending the final approval from the IEPA. Upon approval we will then be able to pump clear water into the system.

The Downs Crossing water main extension project is progressing with most of the pipes to be installed in the ground by the end of May. The tank tower is finished being painted (blue) and next is painting the Downs logo on it. There is 1500 ft. left to mark. We will need to acquire storm sewer easements and move to the south side of Rt. 150 for the remaining 500' of pipe installation for a total of 3000' of pipes in the Village. Remaining work will be onsite electricity and fencing installed with the project to be completed and operational by September.

Downs Streetscape bids were held on May 1, 2025, with two bidders. The low responsive bidder is Knapp Concrete Contractors at \$1,721,712.12 which was \$70,737.93 below the engineers' estimate. Knapp's bid also included alternative bids for 8 benches, 5 trash receptacles and 4 planters for \$27,000. If these items are purchased and the project finishes at the bid price, the congressional grant and McLean County Highway funds dedicated to Seminary Street overlay, should cover the full construction amount and engineering costs incurred after 2/17/23 for a total of \$1,748,712.12. MSA's professional services agreement for construction administration, staking and observation was approved for \$199,035. The Streetscape project should be completed by Labor Day.

The Village Market will relocate to Dooley Park this year due to the Streetscape construction.

Other legislative action included ordinance updates on fencing, fee schedules, municipal codes for chapters 14-zoning, chapter 11-building, and a revised Village zoning map. Yearly employee increases and new hires were approved. In addition, the single audit was completed for FY 2024. The (first-time) single audit was required due to receiving federal funds of over \$750,000 and the report will be filed with the IEPA.

Large dumpsters/containers will be available for disposal of bulk items. Public works staff will be available with a mini excavator to move large items into the dumpsters and to assist with unloading vehicles if needed. Tips to Avoid Common Ordinance Violations!

Common ordinance violations in the Village are overgrown grass/weeds and garbage/refuse on the property. Failure to comply with the ordinances is subject to fines. Please keep our community safe and healthy. Tall weeds and garbage/refuse can draw unwanted animals hiding within these conditions.

Weeds

It is unlawful to permit any weeds, grass or plants other than trees, bushes, flowers or other ornamental plants to grow to a height exceeding twelve (12) inches anywhere in the Village (Chapter 16, Art. 1. Sec. 1).

Garbage/Refuse

The owner, occupant or lessee of any premises shall remove from their premises or otherwise dispose of all garbage, ashes, debris, rubbish, refuse and trash, and shall keep the premises free and clear of any accumulation of such garbage and debris (Chapter 4, Article II, Sec. 4).

Speeding

We've had a number of complaints about drivers speeding. Please note that most speeds in the Village are 25 mph. With warmer weather there are more walkers, children riding bikes, dog walkers and strollers on the roadways. We are increasing traffic enforcement. Follow the speed limits and avoid a ticket. Please slow down and keep our streets safe for everyone!

Grass Clippings on the Streets

A reminder when mowing to not blow grass clippings onto the street. It can be extremely slippery and dangerous for riders on bikes, scooters and motorcycles.

Bulk Pickup—First Garbage Day Pickup of the Month

Do not forget that the first garbage pickup of each month is our contracted bulk waste pickup for the Village. If you have a large item or a lot, please call GFL customer service prior to the scheduled pickup. Please remember, Dumpsters at residences, businesses, and parks are private and not for public use. If you have a need for a dumpster you can call GFL customer service at 309-688-0760 to order one.

Public Safety

Applications for use of Golf Cart and Utility-Terrain Vehicles

May 1, 2025-April 30, 2026

Permits must be obtained to operate a qualified golf cart or utility-terrain vehicle. Permits shall be granted for a period of one (1) year and <u>must be renewed annually.</u> Applications are available on the Village of Downs website at www.villageofdowns.org. The cost of the permit is \$50.00 per golf cart or utility-terrain vehicle.

GOLF CART UTV INFORMATION/SPECIFICATIONS/REQUIREMENTS DEFINITIONS: Per Chapter 8 Article X of the Village of Downs Code are located on the website www.villageofdowns.org.

An officer will schedule an inspection time with you. Valid Permits must be located in a visible location as pointed out by the Officer during your inspection. Just a reminder that these vehicles are not to be driven or parked on Seminary St. which is a county roadway. You could be ticketed.

To reserve the pavilion for an event or a meeting or to find/verify open rental dates, contact the Village Hall **between 8:30 am to 12:30 pm Monday through Friday** at 309-378-3221. You can also check the calendar on the website to see currently reserved pavilion dates.

The rental agreement and clean-up checklist can be printed from the village website. Click forms and applications on the homepage, then click Pavilion rental agreement and checklist separately to download and print the two forms. You can also pick the forms up at the Village Hall.

When you pay your rental fee and turn in your signed rental agreement form at the Village Hall, the pavilion will be reserved for you for that date and time.





Billing

ALL QUESTIONS REGARDING BILLING ISSUES INCLUDING PAYMENT ARRANGMENTS NEED TO BE DIRECTED TO THE VILLAGE HALL AT 309-378-3221 DURING OFFICE HOURS MONDAY THROUGH FRIDAY 8:30 a.m.—12.:30 p.m.

REMINDER: The billing due date is the **15th of the month**. Payments received after the 15th are subject to the late fees. If not paid by the 25th of the month, and the office has to call you regarding payment, there will be an additional fee of \$20. If not paid on the 26th, shut off of water can occur. To reconnect, there is a additional fee of \$30.

The Village is using an **ACH** (automatic withdrawal) program. This program has NO FEE to you! If you sign up for this program, you will continue to receive your monthly bill. On the 15th of the month, the Village will withdraw the entire amount due from the checking or savings account you provided on the authorization form. Authorization forms are on the website and will need to be submitted to the Billing Office by the 1st of the month you wish your first payment withdrawal to be made.

Reminder: If an ACH comes back as NSF it is treated like a check, and cash or money order is needed to cover the \$25 NSF fee + the amount of the bill. A 2nd NSF will result in no longer being eligible for ACH and all payments will need to be in cash or a money order. Please put your <u>service number</u> on your payment.

Food Vendors and Mobile Food Trucks

Requires A Permit

It is unlawful for any vendor, solicitor or temporary merchant to engage in such business or to employ another in such business within the Village without first applying for and receiving a permit from the Village.

Vendor permits and fees vary depending on whether the vendor is participating in a Village event such as the 4th of July, a different Village sponsored event, or if the vendor is selling or offering to take order in a mobile type fashion.

If a vendor is applying for participation in a Village sponsored event, please contact the event sponsor/committee.

The following are general vendor rules and regulations for all other vendors:

- **Application and Permit** A fully completed application with all required fees and attachments must be submitted to and approved by the Village, and a permit issued to the vendor.
- **Fee** There is vendor permit fee of \$100.00 for a permit for vendors that are forprofit. There is no fee for nonprofit vendors. The fee listed is per day.
- Additional Licenses or Permits If a vendor is required to have additional permits or licenses, such as from the McLean County Health Department, that license or permit must be submitted with the application.
- **Permit Displayed** All vendor must carry on their person and show upon request a copy of the permit issued by the Village.

Exempt Parties - The following are exempt parties that are not required to obtain a permit:

- Persons selling agricultural food products on commercial or private property with written permission of the property owner. At no time shall they operate in a public street or right-of-way without written permission from the Village.
- Vendors of prepared foods who are invited to sell their products as a part of a private or public special event or festival sponsored by a nonprofit or public organization.
- Non-Profit groups selling prepared foods who are invited to sell their products by a
 commercial or private property owner for a temporary fundraising event. At no time
 shall they operate on a public street or right-of-way.

Public Works

Water Sewer report for March 2025.

The average iron concentration for the finished water was **0.98** ppm. Monthly bacteriological testing on the raw, finished and distribution samples were all satisfactory, fluoride concentration was **.5.** The volume of water pumped for the month was **3.823** million gallons, averaging **127,444** gallons per day. The sewer lift station pumped **2.6886** million gallons for the month, averaging **89,600** million gallons per day.

This will be at no cost to the homeowner as it is Village Property.

Please continue to be cautious of our Village workers who are out and about. We want to make sure the Village is safe for the residents and ourselves.

We are getting closer to going online. With all new projects, there will be kinks to work out, but we are confident they will quickly be resolved. Once we have a more accurate date of officially going online, we will post it on Facebook, announce it in the recent news section of our Website, and send out an email through the Notification system.

Monthly Brush Pickup Continues April thru November 2025

Debris pickup will continue, based on the Streets Trustee's direction, the first MONDAY of each month (weather permitting). If the designated Monday pickup is not favorable, we will pick up on the next nice day following that Monday. The following are the rules we will follow with no exceptions.

- Items to be picked up must be burnable and free from all nails, screws, and metal (ex: Leaves, sticks, brush, branches, etc.)
- All items must be within the Village right away on curb, driveway or as close to the road as possible without creating a hazard in the road. (Note: Since we use a backhoe, in most cases, to do this work, we DO NOT want to tear up or rut yards or ditches. If we can't reach the debris from the road or a driveway, we WILL NOT pick it up.
- If you know you will have a larger than normal pile, please contact the office so they can make the streets department aware.

Please note that there is NO BURNING in the ditches or on the road. Doing this causes clogging and backup in the ditches and culverts. It can also damage the road surface causing us to spend what little tax dollars we have, to fix these issues.

Illegal Dumping

Please do not dump yard waste and ANY other items at the entrances to Kickapoo Park, Village storage yard, and/or along Huff Rd South of Main St. Violators will be caught and fined accordingly!



The following describes each planned event at a high level. Further details and changes will occur during final planning by the committee or sub-committee in charge of the event. Budgets have been estimated based on last year's expenditures and revenue. Some events have been eliminated due to lack of participation or they were merged with something else.

- **Dooley Park Cruise-In** This event will be held on the first Saturday in June in Dooley Park from 3 7 pm. There will be no rainout date.
- **Village Cleanup Day** This event will be held on the first Saturday in June each year. We hope to have containers for garbage, recycle, electronics, batteries, tires (extra fee). Home pick up can be arranged for a donation.


