From the Desk of the Mayor

YOU MUST TURN OFF YOUR WATER SOFTENER!

Water softeners are no longer needed and can be harmful to your pipes within your home if you over soften the water. We are currently at 70% and will be increasing over the next month to our target of 75-85%. You do not want to be at 90%+ softened water.

What do you need in your home? We highly recommend a whole house filter to “catch” any sediment coming into your home. Personal choice in taste of the water varies for everyone. If you choose to have an RO system that will be based on that taste and personal concerns. For reference, I don’t have RO but do have a refrigerator filter. I have heard of contractors testing the water and telling residents to keep their softeners because their tests show the water to still need it. It will be your choice to continue using but the Village has provided adequate warning.

The next question has been how much will the water rates increase? The Board of Trustees adopted the new OMR (operations, maintenance & repair), debt service and capital cost rates. These new rates will take be reflected on your January 2026 bill. We do not anticipate needing to raise them again but will consider, like other small towns, an automatic 3-4% rate increase each year. The new rates will be explained later in the newsletter.

Mayor Monday continued this month, but I will suspend them until the Spring.

Downs project updates:

- 1) The new water plant is 100% operational and punch list items are being completed.
- 2) Downs Crossing Tower and watermain extension. Water main to Downs Crossing has been permitted by IEPA. We are finalizing telemetry controls for the new tower, fencing, and completing the final tasks and tests for the water tower IEPA permits. Weather is a factor for bringing the tower online so this might be elongated for now.

- 3) Streetscape project is complete except for the punch list. Lights look amazing and provide a nice welcome to Downs. We are putting a limestone cap on the walls and then all the railings can be installed. We hope this project will be completed before Christmas.
- 4) The sidewalk project has been completed from Seminary to Price St on the southside of Main St.
- 5) Due to weather S. Lincoln St Road improvements will be pushed to the Spring or when weather allows.
- 6) The board has authorized me to continue with a new village hall using a municipal program that allows the building to be built and leased back for ownership. We have outgrown our current location and the work environment is less than ideal. The new building will provide room for all hall operations and future expansion needs that we could anticipate. The current building will then be leased out to a business for our downtown.
- 7) The board is also considering solar panels on the Les Fitzwater PW building to reduce the cost of electricity for the new water plant. The options being considered could offset costs by 20-40% depending on the option.

Village of Downs Board of Trustees Meeting Overview December 11th, 2025, 7 pm @ Village Hall & via TEAMS

Executive order **2021-9** by the Governor of Illinois allowed this meeting to be held via Zoom, telephone and at the Village Hall.

1. Mayor Mike James called the December 11, 2025, meeting to order at 7:00 p.m.
2. Trustees present were Maureen Roach, Diana Reynolds, Stephanie Adkisson, Sarah Gassaway, Brian Warfel and Toby Twyford. There was a quorum present. Also present were Mayor Mike James, Clerk Rachel Eagles, Treasurer Julie Bakewell, and Village Attorney Dawn Wall.
3. The Pledge of Allegiance was recited.
4. Reports from specific departments can be found in the flyer.
5. The board reviewed rezoning recommendations from the Zoning Board of Appeals.
6. Trustees received updates on zoning and development matters, including annexations, zoning map amendments, and variances that support residential growth and development within and near the Village.
7. Community events were highlighted, including the success of the annual Cookies with Santa event, which welcomed approximately 300 children, and early planning for the Fourth of July celebration this summer.
8. Engineering and infrastructure updates focused on continued progress across several major projects. The new water plant is producing high-quality water as final adjustments and punch list items are completed, with a reminder to residents that in-home water softeners are no longer needed as they could cause possible plumbing damage due to over-softening if continued use ensues.
9. Downtown streetscape improvements are nearing completion, with remaining items expected to be finished in the coming weeks, weather permitting.
10. Updates were also provided on the water main extensions and new water tower project, road project delayed by winter conditions, and overall financial planning, including discussions related to water rates and other financial items were covered.

Billing Billing Questions, Issues, and Payments

All questions regarding billing issues including payment arrangements need to be directed to the Village Hall at 309-378-3221 during office hours. Monday - Friday, 8:30am - 12:30pm.

REMINDER: *The billing due date is the 15th of the month. Payments received after the 15th are subject to the late fees. If not paid by the 25th of the month, and the office has to call you regarding payment, there will be an additional fee of \$20. If not paid on the 26th, shut off of water can occur. To reconnect, there is an additional fee of \$30.*

The Village is using an **ACH** (automatic withdrawal) program. This program has **NO FEE** to you! If you sign up for this program, you will continue to receive your monthly bill. On the 15th of the month, the Village will withdraw the entire amount due from the checking or savings account you provided on the authorization form. Authorization forms are on the website and will need to be submitted to the Billing Office by the 1st of the month you wish your first payment withdrawal to be made.

Reminder: If an ACH comes back as NSF it is treated like a check, and cash or money order is needed to cover the \$25 NSF fee + the amount of the bill. A 2nd NSF will result in no longer being eligible for ACH and all payments will need to be in cash or a money order. Please put your service id on your payment.

Billing Rates Increase January Bill 2026

Several changes have happened to the water billing rates for the January bill. At the end of 2024 we raised the debt service rate to help pay for the new plant loan to the minimum the IEPA would accept at that time. We have now raised it to include the new water tower. The water (OMR) and Capital Improvement rates have not been increased since 2009. Now that the new plant is completed and producing better quality water, we have raised the water rates to cover the actual cost of producing/treating/delivering the water. We have raised the Capital Improvement rates to better cover the actual costs due to inflation. See the chart below to compare the previous rates with the new rates.

Water Sewer report for November 2025.

The average iron concentration for the finished water was **.03** ppm. Monthly bacteriological testing on the raw, finished, and distribution samples were all satisfactory; fluoride concentration was **.5**. The volume of water pumped for the month was **2.696** million gallons, averaging **89,866** gallons per day. The sewer lift station pumped **1.848** million gallons for the month, averaging **61,600** million gallons per day.

- 6 outdated water meters/transmitters replaced with updated units
- 1 Drain tile replacement
- 28 JULIE tickets within Village
 - 1 Streets/Water Department
 - 15 outside companies
- 11 JULIE tickets outside Village (1 was an extended ticket, no need to remark)

The new water plants' softening level is down to what we believe is an ideal level. Any additional water softening is **not necessary**, but that is the homeowner's decision to make.

Weather permitting, water meters/transmitters replacement changeout will continue. This will be at no cost to the homeowner as it is Village Property.

We said goodbye to the always smiling, Jon Bettisch early November. We wish Jon well and the best of luck in his new chapter.

Please continue to be cautious of our Village workers. We want to make sure the Village is safe for the residents, visitors and ourselves.

Village Snow & Ice Removal

Please Help us Make Plowing Easier, Safer, and more Efficient

The Village doesn't have a snow parking ban law, and we prefer not to create one because we know we can rely on YOUR assistance and cooperation to help make our job easier. The following outlines our procedures and will be adjusted as needed:

We will usually precede each storm with salting intersections, hills, curves, and trouble areas. Snow removal will start at ~2" and will focus on getting one pass through all streets and keeping them open, until snow stops. Cars parked along the side of the roads will slow this process down and you may end up with a lot of snow around it. Please help us by parking your car(s) preferably in your own driveway, during storms where we are expecting 4"+ of snow and/or high winds. Once removal is completed and the snow has stopped, we will come back through to widen, cleanup and spread salt.

Illegal Dumping

Please do not dump yard waste and ANY other items at the entrances to Kickapoo Park, Village storage yard, and/or along Huff Rd South of Main St. Violators will be caught and fined accordingly!

Please remember, Dumpsters at residences, businesses, and parks are private and not for public use. If you have a need for a dumpster you can call GFL customer service at 309-688-0760 to order one.

Door-to-Door Sales

Permit Required

Door-to-door solicitation permits are needed PRIOR to doing solicitation door-to-door. No warnings will be granted. Please report anyone that does not have a permit to come to your door. Please try and get their name and car make/model/color. Solicitors without a permit will be fined.

Bulk Pickup—First Garbage Day Pickup of the Month



Sample of items not taken - electronics, appliance with a compressor, batteries, landscaping material, bricks, block, construction material. Recycling Guidelines

Passed down from our Local Pickup Crew:

- Label recycling with the word Recycle or the Recycle Symbol.
- Place recycling well separated from trash. For example: Place your containers on separate sides at the end of your driveway.

Following the above guidelines will help our Recycle and Trash crews pickup the correct items and not leave some behind.

Notary Signed Letters Due January 31st

Letters have been mailed to property owners within the Village of Downs along with a petition of annexation and a signature page. All property owners will need to submit the signed signature page that has to be notarized. You can have the paperwork notarized by a notary of your choice or call the Village Hall at 309-378-3221 to arrange a time.



All Building Permits

All Building and Demolition Permit Applications must be processed, approved, and issued a permit number, BEFORE WORK CAN BEGIN. This includes small projects, renovations, and new builds which could take up to 2 weeks to process. Please leave enough time before working on your project.
