CALL TO ORDER:

The special meeting of the Board of Trustees was called to order by Mayor Peterson at 1:00 p.m. at the Town Hall, 1026 Park Avenue.

ROLL CALL  
PRESENT:

Mayor Peterson; Mayor Pro-Tem Kudron; Trustees Bruton, Murphy, and Price; Town Manager White, Town Clerk Carrell, and Town Code Administrator ORourke.

NEW BUSINESS:

**Consideration to either cancel or move forward with the 2018 Grand Lake Fireworks Show.**

Judy Tumblin, Grand Lake Fireworks Committee, 771 County Road 464. Mrs. Tumblin believes although they worked really hard to collect the money for the show, it's just not worth it to take the risk. She supports in canceling the show.

Mandy Hanifan, having been a previous fire fighter and knowing how dry it is Mrs. Hanifan falls in favor of canceling the fireworks show this year. She believes with resources being so limited across the state, with all the other fires currently going it would be in the best interest of the Town to cancel.

Mike Ladefoged, 207 Garfield. Has started putting together a movie by the lake with the Chamber of Commerce, in order to provide our visitors some fun entertainment.

Judy Tumblin, Grand Lake Fireworks Committee, 771 County Road 464. The committee has already started putting together a "Parade of Lights" on the lake, more details will be released once they have a plan put together.

David Raffaelli, 813 Portal Road. Mr. Raffaelli is a 32 year resident of Grand Lake and doesn't recall the fireworks ever being cancelled since he has been here. After checking the weather for Wednesday night, he doesn't believe it should be of concern. Mr. Raffaelli thinks everyone is shell shocked from the recent fire, but thinks the show must go on.

Brett Schroetlin, Grand County Sheriff's Office. Sheriff Schroetlin wanted the Board to be aware that due to limited resources if a fire was to happen we could have a real problem on our hands. The Sheriff and his Deputies are ready to proceed with whatever the Board decides.

JT Piribek, is in support of canceling the fireworks show. He would much rather have his business and the Town be there on July 5<sup>th</sup> then risk it for a show.

Mike Long, Grand Lake Fire Chief. Supported Sheriff Schroetlins statement of resources being limited. Feels that the Town would receive far less criticism if we were to cancel rather than take the risk of something happening.

Mayor Pro-Tem Kudron stated he went around to local businesses and collected signatures in favor of canceling the fireworks show. Safety first.




