Fire Chief Gari Gill was contacted regarding the fire suppression system. He has done a walk through orientation. A grand opening will be held in conjunction with Sundance Square.

Ms. Lenz stated a donation of \$2500.00 has been received from the Downtown Main Street for the Sundance Square.

Clerk Treasurer Kathy Lenz presented the council with an update from the Wyoming Smart Capital Network. The City was one of the first municipalities to get involved with this program 10 years ago. The program has had very favorable results in creating jobs and commerce.

Ms. Lenz stated that there are now three pots of money available for use. This is due to the Rural Development Loan Network and the North East Economic Development. The Sundance State Bank is a local participant.

Mayor Brooks stated he would like the City Council to be thinking about how franchise agreements could affect the City. Discussion was held. No action was taken.

## Department Head Reports:

Crook County Sheriff Jeff Hodge gave the City Council a monthly report. A total of 116 calls were made in January for the City. Sheriff Hodge says the transition has gone smoothly.

Fire Chief Gari Gill reported he has received approval for the VFA Grant, which is a 50/50 grant he discussed at the January 5, 2021 council meeting. This grant will be used for equipment upgrades.

Chief Gill stated he has applied for an AFG Grant in the amount of \$250,000.00. This is a 5% grant. The funds will be used to purchase a rescue unit. If approved, The Sundance Volunteer Fire Departments share will be approximately \$12,500 which will be obtained with fund raisers held by the department. The meeting for this funding has not been set. The time frame will be 2023.

COUNCIL MEMBER HILTY MOVED, COUNCIL MEMBER STEVENSON SECONDED a motion to allow the Mayor to sign the grant application. All Ayes, MOTION CARRIED.

Chief Gill reported two new recruits have joined the department. Mr. Gill plans to get his department orientated with the fire suppression system at Old Stoney. Bugs are being worked out with the alarm system.

Clerk Treasurer Kathy Lenz presented the council with a sign permit application as the City Land use Commission did not have a January meeting.

COUNCIL MEMBER WILSON MOVED, COUNCIL MEMBER MARCHANT SECONDED a motion to approve a sign permit for Sundance Lodging LLC DBA Serena Inn & Suites. All Ayes, MOTION CARRIED.

Ms. Lenz presented the City Council with a copy of the Quarterly financial report from the Sundance Kids Prints Inc.

City Attorney Hughes and Clerk Treasurer Lenz will work on a proposal and Ms. Lenz will get the ordinance information to the council for their review before next month's meeting.

City Attorney Mark Hughes has received correspondence from Judge Castano regarding the transition of City Ordinance enforcement.

City Attorney Mark Hughes explained briefly how some franchise agreements work. Discussion will be held at the next month's Council Meeting.

COUNCIL MEMBER WILSON reported to the Mayor and Council information he has gathered for the Solid Waste District Project. His research showed the County has grown a great deal in the past 12 months. The town of Sundance has shown growth as well. His hope is the Crook County Commissioners will take the current growth into consideration for how this will affect the need for refuse disposal in the future. He will attend the County Commissioners meeting tomorrow.

Mayor Paul Brooks commented on a electric charging station which has been proposed by Powder River Energy Corp. Mayor Brooks has reached out to the City Land Use Planning Commission for their input. Discussion was held. No action was taken.
