City Engineer Karla Greaser updated the council on the Sundance West Water Storage Tank project. Some of the inside work in the pump station has been started and the underground water line work is complete.

MS Greaser reported on the Sundance Kid Tank Project. She stated the 100% design plans have been completed and submitted to WDEQ for review. After DEQ's approval is received the City will start the bidding process with construction planned to begin this summer.

Clerk Treasurer Kathy Lenz reported on Old Stoney. More office space is being created, due to more interest in permanent offices. The Museum is getting moved in. The hope is to have a Grand Opening late May 2021.

The City of Sundance will hold ownership of the Statue. The Chamber has offered to make a donation to the Sundance Square Park for the Kid's new home. All ayes, MOTION CARRIED.

Department Head Reports:

Fire Chief Gari Gill reported 75 calls for the year. The Department had 34 EMS assists, 21 wrecks, 7 extrications, 15 wild land fires and 1 structure fire.

Mr. Gill stated that E.T. Sports has worked with the Fire Department on a side by side recreational vehicle. The Department will be selling 500 tickets for a fund raiser scheduled later this year.

City Engineer Karla Greaser thanked the City Council for the appointment for the year. She says Sundance is a great group to work with.

Clerk Treasurer Kathy Lenz invited the Council to attend the County Commissioners meeting for the discussion on the Solid Waste District.

Ms. Lenz reported that Sheriff Jeff Hodge has been very helpful in the transition of the Sundance Police Department to Crook County Sheriff. Three of the four Police vehicles have been sold.

City Attorney Mark Hughes thanked the City Council for his appointment for year 2021.

Mayor Paul Brooks stated the town's efforts to make Sundance an attractive place to live is paying off. New business is coming in. Vacant houses are selling. The new Sundance Square will be a nice showcase. He commends the efforts of all involved to keep moving forward in cleaning the town up and making it an attraction to be proud of.

City Attorney Mark Hughes explained the Public Hearing. The Public Hearing is a petition for annexation known as the Stuart Annexation. It is a portion of S 27th Street which was not included in the Corporate City Limits.

At 7:30 p.m. a Public Hearing was held. No public comments were heard. The Hearing closed at 7:35 p.m.
